

Pursuant to 12-47-312 of the Colorado Revised Statutes and Rule No. 7 of the Local Rules of procedure, I have the following report to make concerning the results of my investigation of the application you have filed for a new Tavern Liquor License at Whistling Pines Gun Club West, Inc. dba Whistling Pines Gun Club, 4750 Peace Palace Point, Colorado Springs, Colorado. 
