Section 1. The City Council hereby finds, determines and declares that it is in the

best interest of the City and its citizens to vacate the public right-of-way as described

on Exhibit A, and accordingly that the same is hereby vacated as follows:

Vacating a portion of public right-of-way consisting of 1,227 square feet located

North and West of W. Colorado Avenue and S. 7TH Street, respectively. Public

utilities are located within the right-of-way and will be retained and

accommodated by a separate utility easement.

Section 2. This ordinance shall be in full force and effect from and after its final

adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title

and summary prepared by the City Clerk and that this ordinance shall be available for

inspection and acquisition in the office of the City Clerk.

## **EXHIBIT A**

Legal Description - Alley to be vacated

That portion of Block 4, Cahn's Addition To The City Of Colorado Springs, in El Paso County Colorado described as follows:

Beginning at the southwest corner of Lot 4 in said Block 4;

- 1. thence South 72 degrees 58 minutes 36 seconds East, along the southerly line of said Lot 4 a distance of 75.28 feet to the southeast corner thereof;
- 2. thence South 0 degrees 05 minutes 32 seconds East along the westerly line of South 7th Street (platted as Pitkin Street) 16.03 feet to the northeast corner of Lot 3 in said Block 4;
- 3. thence North 72 degrees 58 minutes 15 seconds West, along the northerly lines of Lot 1, 2 and 3 in said Block 4, a distance of 84.95 feet to the northwest corner of said Lot 1;
- 4. thence North 34 degrees 57 minutes 07 seconds East along the easterly line of McKinley Place (platted as Grant Street) 16.10 feet to the point of beginning.
