AN ORDINANCE AMENDING ORDINANCE NO. 15-86 (2016 APPROPRIATION ORDINANCE) FOR Α SUPPLEMENTAL APPROPRIATION TO THE CITY-FUNDED CIP FUND IN THE AMOUNT OF \$356,250 FOR THE CONSTRUCTION OF SEVERAL TRAFFIC SIGNAL PROJECTS


