AN ORDINANCE VACATING PORTIONS OF A PUBLIC RIGHT-OF-WAY, SUBJECT TO THE RETENTION OF PUBLIC UTILITY AND PUBLIC ACCESS EASEMENTS, CONSISTING OF 5,700 SQUARE FEET ORIGINALLY PLATTED IN THE WILLIAMSONS ADDITION TO IVYWILD LOCATED SOUTH OF EAST NAVAJO STREET AND WEST OF SOUTH NEVADA AVENUE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. City Council hereby finds, determines and declares that it is in the best interest of the City and its citizens to vacate and hereby vacates, subject to the retention of public utility and public access easements across the entire vacated right-of-way, portions of a public right-of-way consisting of 5,700 square feet originally platted in the Williamsons Addition to Ivywild located south of East Navajo Street and west of South Nevada Avenue, as described on Exhibit A and depicted on Exhibit B, both of which are attached hereto and made a part hereof.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.




