# AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF COLORADO SPRINGS RELATING TO 17.7 ACRES LOCATED EAST OF MARKSHEFFEL BOULEVARD AND SOUTH OF BARNES ROAD EXTENSION FROM PIP-2/SS/AO (PLANNED INDUSTRIAL PARK WITH STREAMSIDE AND AIRPORT OVERLAYS) TO PBC/AO (PLANNED BUSINESS CENTER WITH AIRPORT OVERLAY) 

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS

Section 1. The zoning map of the City of Colorado Springs is hereby amended by rezoning 17.7 acres located east of Marksheffel Boulevard and south of Barnes Road extension as described in Exhibit A and depicted in Exhibit B, which are attached hereto and made a part hereof by reference, from PIP2/SS/AO (Planned Industrial Park with Streamside and Airport Overlays) to PBC/AO (Planned Business Center with Airport Overlay), pursuant to the Zoning Ordinance of the City of Colorado Springs.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.
