A secondary concern is property values decreasing as a result of said proposed complex.

For example they can revitalize a neighborhood; but this neighborhood is already new and doesn't require an apartment building to spruce up the area. Another benefit is to provide family's with lower cost of living. This can attract a lower demographic in regards to income, class, and education of residents to the area. While



one can argue that diversity is beneficial for a community, it can hinder as well. Our neighborhood is already home to diverse individuals and families.

Since hearing about the proposed complex I have spoken to many neighbors who share the same view points and strongly oppose the plan to add an apartment complex so close to our brand new single family homes.
