# **ORDINANCE NO. 17-3**

AN ORDINANCE VACATING PORTIONS OF A PUBLIC RIGHT-OF-WAY CONSISTING OF 0.043 ACRES LOCATED AT THE INTERSECTION OF VISTA DEL FLORES STREET AND VISTA DEL TIERRA DRIVE AND PORTIONS OF EXCESS RIGHT-OF-WAY CONSISTING OF 0.145 ACRES LOCATED ALONG DUBLIN BOULEVARD

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. City Council hereby finds, determines and declares that it is in the best interest of the city and its citizens to vacate and hereby vacates portions of a public right-of-way consisting of 0.043 acres located at the intersection of Vista Del Flores Street and Vista Del Tierra Drive and portions of excess right-of-way consisting of 0.145 acres located along Dublin Boulevard, as described on Exhibit A and depicted on Exhibit B, which is attached hereto and made a part hereof:

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.
