## ORDINANCE NO. 17-9

A ORDINANCE AMENDING ORDINANCE NO. 16-116 (2017 APPROPIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE PUBLIC SPACE AND DEVELOPMENT FUND IN THE AMOUNT OF \$800,000.00 TO FUND THE COMPLETION OF THE JOHN VENEZIA COMMUNITY PARK

WHEREAS, each year the Parks, Recreation and Cultural Services Department conducts a public process to assist in establishing priorities for the annual Capital Improvement Program (CIP) budget. On June 9, 2017, the Parks and Recreation Advisory Board reviewed and recommended the Parks CIP Budget for inclusion in the City's CIP Budget; and

WHEREAS, the John Venezia Community Park is currently under construction and is anticipated to be completed in July of 2017; and

WHEREAS, the Parks Department has been assembling funds to complete the construction of the John Venezia Community Park since 2006; and

WHEREAS, the remaining elements to be funded are the tennis and pickleball courts and a shade shelter to support the activities at these facilities; and

WHEREAS, City Parks, Recreation & Cultural Services requests the approval of City Council to approve a supplemental appropriation for the John Venezia Community Park in the amount of \$800,000,00

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 16-116 is hereby amended by increasing the Public Space and Development fund expenditure appropriation in the amount of \$800,000, which will provide funding to complete the construction of the John Venezia Community Park. The source of funds is the available fund balance in the PLDO fund.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.
