AN ORDINANCE AMENDING SECTION 102 (REGULAR COUNCIL MEETINGS; UTILITY BOARD) OF PART 1 (ELECTIVE OFFICERS) OF ARTICLE 2 (OFFICERS OF THE CITY) OF CHAPTER 1 (ADMINISTRATION, PERSONNEL AND FINANCE) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO UTILITY BOARD

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 102 (Regular Council Meetings; Utility Board) of Part 1 (Elective Officers) of Article 2 (Officers of the City) of Chapter 1 (Administration, Personnel and Finance) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

1.2.102: REGULAR COUNCIL MEETINGS: UTILITY BOARD:

* * *

- C. In accord with City Charter subsection 6-40(a), the City Council shall serve as the Board of Directors for Utilities ("Utilities Board"). The President of Council shall chair Utilities Board meetings in accord with Utilities Board bylaws.
- Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
