ORDINANCE NO. 17-39

AN ORDINANCE AMENDING ORDINANCE NO. 16-116 (2017 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE GENERAL FUND IN THE AMOUNT OF \$100,000, AND TO THE CONSERVATION TRUST FUND (CTF) IN THE AMOUNT OF \$150,000, FOR REPAIR OF THE BANCROFT PARK BAND SHELL

WHEREAS, the band shell at Bancroft Park was damaged by fire on January 27, 2017; and

WHEREAS, since February 24, 2017, the band shell has been boarded up by the Parks Department to protect the remaining structure, rendering it unusable for events; and

WHEREAS, the City Council believes it is in the best interests of the health, safety, and welfare of the City of Colorado Springs, its citizens, and the Westside neighborhood to repair the band shell expeditiously so that it can be safely used for events; and

WHEREAS, it is the intent of the City Council to ensure that repairs to the band shell be fully funded through this supplemental appropriation and such additional supplemental appropriations as may be necessary in the future.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 16-116 is hereby amended by increasing the expenditure appropriation of the General Fund in the amount of \$150,000 for repair of the band shell at Bancroft Park. The sources of funds are insurance proceeds and the unrestricted fund balance.

Section 2. That Ordinance No. 16-116 is hereby amended by increasing the expenditure appropriation of the Conservation Trust Fund (CTF) in the

amount of \$150,000 for repair of the band shell at Bancroft Park. The source of funds is the available fund balance in the CTF Fund.

Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
