PRESCRIBING THE SALARY OF THE CITY AUDITOR

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF

COLORADO SPRINGS:

Section 1. In accordance with City Charter § 3-10(e) and City Code

§ 1.2.203, the annual salary of the City Auditor, shall be prescribed by ordinance.

Section 2. Ordinance No. 15-42 (approving the salary of the City Auditor) is

hereby repealed, and until and unless amended by ordinance, the salary of the City

Auditor is prescribed at \$148,780.80, together with applicable benefits, retroactively to

January 1, 2017.

Section 3. This ordinance supersedes all prior ordinances to the extent such

prescribe the salary of the City Auditor and are inconsistent herewith, including

Ordinance Nos. 13-59, 13-76, and 14-33, and shall remain in effect until superseded by

ordinance.

Section 4. This ordinance shall be in full force and effect from and after its final

adoption and publication as provided by charter.

Section 5. Council deems it appropriate that this ordinance be published by title

and summary prepared by the City Clerk and that this ordinance shall be available for

inspection and acquisition in the office of the City Clerk.
