AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF COLORADO SPRINGS RELATING TO 5.012 ACRES LOCATED SOUTHEAST OF FILLMORE STREET AND GRAND VISTA CIRCLE FROM R/HS (RESIDENTIAL ESTATE WITH HILLSIDE OVERLAY) TO PUD (PLANNED UNIT DEVELOPMENT – MULTI-FAMILY RESIDENTIAL, 18.16 DWELLING UNITS PER ACRE AND 55 FEET MAXIMUM BUILDING HEIGHT)

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The zoning map of the City of Colorado Springs is hereby amended by rezoning 5.012 acres located southeast of Fillmore Street and Grand Vista Circle as described in Exhibit A, which is attached hereto and made a part hereof by reference, from R/HS (Residential Estate with Hillside Overlay) to PUD (Planned Unit Development – Multi-family residential, 18.16 Dwelling Units per acre and 55 foot maximum building height), pursuant to the Zoning Ordinance of the City of Colorado Springs.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.
