I live on Friendship Lane and am writing this letter in support of the path being discussed in the above file. I have lived in the neighborhood for 7 years and use this access twice per day, every day. It is one of the many pleasures of living in this neighborhood to have access to the park to walk my dog daily.

I know that there were initial concerns from some residents regarding increases in traffic and parking issues. I want to mention that this access has actually existed long before I became a resident in the neighborhood, and none of the concerns that have been mentioned have actually seemed apparent. I see occasional walking and bicycling through the path of folks going to Holmes Jr. High in the morning and afternoon, which I suspect lowers, if anything, automobile traffic on our street by parents dropping off or collecting their children from school.

The completed path actually directs users effectively to stay on the path and to avoid other property boundaries. It is also aesthetically pleasing and a valuable addition to the neighborhood. It markedly improved the quality of the fence line on the north boundary of the property, which had fallen into some disrepair.

Hi! I'd like to voice my strong support for the Tolerance Trail, connecting Friendship Lane to Pioneer Park in Colorado Springs.

I grew up on Friendship Lane, which is just a few minutes walk from the park. As a child, we often used what is now the beautiful pathway to get to the park. Had we been unable to do so, we would have needed to add about 2/3 of a mile and walk all of the way around the park on Mesa, Fontmore, and Panorama. This is a much busier and more dangerous route, and as a child would not have been comfortable getting to the park that way.

I also had many friends who used the same pathway to walk from the residential neighborhoods on the south and west sides of the park to get to Coronado or Holmes. Once again, had the path not been available, they would have needed to take a much less safe and convenient route.

The creators of this plot created a beautiful, safe, improved path. It has interesting local vegetation and decorative border rocks, and a very sturdy wood fence on both sides of the path. It is flat, and easily and safely navigable by foot, bike, or stroller. A few folks seem concerned about setbacks from the trail decreasing - but before the trail was improved, people used the whole lot to get to the park, including the area where the improved path is now. It is now separated from the adjacent lots by a sturdy wood fence, and beautiful landscaping.

I do not believe that improving the trail will increase foot traffic on Friendship Lane. The path has always existed, despite perhaps previously being illegal, and has always been used by folks on both sides of the fence. (I daresay that I remember using that exact path with some of the very folks listed on the appeal!) In my opinion, improving the trail will only make the trail safer to use, not increase traffic.

The appeal also mentions "loss of quiet enjoyment:" Once again, people have always used that trail, and I don't anticipate the noise increasing, because I don't think that traffic will. Also, shouldn't people who buy a house adjoining a public park used for youth sports and other activities be comfortable with a certain amount of sound around their house?

And, I believe that if the existence of Tolerance Trail should increase foot or vehicle traffic on Friendship Lane to some degree, that would be a positive result. Public Parks exist for the enjoyment of the public! It is against the interest of the citizens of our city to restrict access to Pioneer Park by reducing access from one particular neighborhood.

Tolerance trail has existed for some time in its current form. I have visited it a few times, and have not noticed any litter, unleashed dogs, increased foot or vehicle traffic, or other problems.

I strongly support the effort to make the Tolerance Trail permanent. In my experience, it enhances the neighborhood by providing a safe route to a shared community resource.

The solutions listed on the appeal seem to be reasonable, if not superfluous. But if they help members of the neighborhood feel more comfortable with the trail, I think they are a great idea.

I have already written a lengthy letter regarding my support of this project as well as my observation about past history and public safety and property issues arising when this park access has been shut off. But now I would like to address some of the letters I have seen in opposition to the proposal that allows the City to accept property and permit public access into and out of Pioneer Park via 10 Friendship Lane.

Most of them deal with an assumed potential for increased traffic and temporary parking by nonresidents. First off we all live in a rather large city and traffic and parking happens. But I would like to reiterate that the park access has always been there and most of the time not one but two lots wide. The proposal would reduce that access down to a designated and authorized pathway. Common sense indicates that if there is any change in parking and traffic at all it will lessen, not increase, as more parents will be willing to allow their children to walk to school and home that safe way along the path and through the small park instead of dealing with the traffic conditions on Mesa Road and Fillmore/Fontmore. One reason that the now one vacant lot has remained vacant is because no one wants to be responsible for cutting off neighborhood access to the park from our neighborhood or through the park to the schools and connecting trails. As a result of this beautiful designated path I also strongly suspect that the vacant lot will sell and a new home will be built. Curb cuts for a new dwelling will further reduce parking opportunities on Friendship Lane.

The neighbor most impacted by the trail was concerned about incursions upon her property. She and other neighbors that live closest to the path moved into the neighborhood many years and even decades after their homes were built and the informal paths through the adjacent lots were already well-established. This designated pathway channels the traffic discouraging any unwanted trespassers. Second, the current owners have put up a beautiful and sturdy fence between the path and her property that should deter future encroachments. My observations of foot and bike traffic in the past few months show that people – including children- are keeping to the path and no longer finding their own way into or out of the park. Logic suggests that will continue.

About 75 per cent of the homeowners in the Friendship - Crescent – Mesa neighborhood voted to change our covenants in order that number 10 could be subdivided in a way to permit this path. The owners have gone through with the subdivision process, have built a fence to protect the neighbor most closely impacted and installed beautiful landscaping to an area that was an eyesore for all the time that I have lived in the neighborhood – going on 30 years. The City is being offered a wonderful gift. I urge acceptance of this gift and that the appeal be denied.

In all the years, and certainly since the lovely path was put in by Patti Freudenburg and Tony White, I have never been concerned about my safety. In fact, I have become acquainted with many other dog owners, both on the Pioneer Park side of the path and the Friendship Lane side. Many of us have commented about how lovely the path is and how very much appreciated it is, as well. People using this path are neighborhood walkers, and occasional bike riders, so traffic and parking issues are non-existent. I have never needed to pick up any trash anywhere near the path. We respectfully submit the following comments, as Colorado SPrings residents living near Pioneer Park. We've lived in this area for 15 years, and we SUPPORT the Pioneer Park extension. Here's why:

 It's a quality-of-life issue. Despite our city's reputation for outdoor-friendly living, we have few nearby outdoor trails available to us without using a car, so access to the Holmes area trails is important. THe nearest major trails, in Red Rocks or Garden of the Gods, are miles from our home and we would need to use sidewalks and cross dangerous access roads to reach them.
It's a safety issue. Without the Pioneer Park access, we (and neighborhood school children) would have to use a narrow sidewalk along Fontmore to access the Holmes area. The Fontmore sidewalk/street is also a seemingly dangerous thoroughfare for neighborhood children who bike to school, when compared with the Pioneer Park accessway.

3. The benefits are demonstrated and the objections seem speculative. When compared with teh concrete benefits of the Pioneer Park access, the assumed rise in crime and vagrancy-type activities cited in the complaint is speculative. Current use of hte Pioneer Park "social trail" does not seem to have increased these activities to an objectionable degree. Indeed, having more people travel through an area may even deter crime in some cases.

4. It's a way to reward generosity. We are impressed with the generous spirit of the landowner who has permitted access. Of course, we clearly understand the desire of those who would prefer fewer people in the neighborhood, and precautions shojuld be taken, but we live in an urban area, not an isolated open space. Anyone who has elected to move into an urban area should reasonably expect to find neighbors and walkers (we have plenty of walkers on nearby sidewalks and far more often than not, that's welcome). This is not Yoder or Guffey.

5. It's a financial issue. We have directly spent \$1000 to help bring the access to reality, and we would like to see our money well spent and not thrown away by last minute objections after the access has been approved and maintained.

Thank you for the opportunity to contact you on this issue, and thank you for helping our city and community to be more livable. We support the concerns of those opposed but think the issue is reasonably clear. Thanks also for making it possible for generous landowners to provide access to more trails in our supposedly walkable city.

As a homeowner in the Pleasant Valley Subdivision, I would like to voice my full support of tolerance for the trail intersecting Pioneer Park and Friendship Lane (Lot 10). The support of this trail tolerance is continually echoed by Colorado Springs residents as evidenced by PlanCOS Survey results:

Vibrant Neighborhoods

4. Focus City resources first and foremost on public safety within neighborhoods (e.g. through increased police patrols and support of neighborhood watch programs).

An objection to this trail tolerance is likely to be made here as Friendship Lane residents may feel that this trail will be used by patrons looking to do harm. In actuality, the line of sight these residents have over this trail is a natural deterrent to would-be criminals. Coupled with a robust neighborhood watch program and the safety of this area actually increases.

Strong Connections3. Physically and visually connect commercial and residential developments to trail and greenway corridors.

Tolerance of this trail does just that. It promotes walkability, decreasing vehicular traffic as well as decreases the walking distance from the Pleasant Valley Subdivision to the commercial district on the corner of Fillmore and Centennial.

Majestic Landscapes

1. Emphasize preservation of undeveloped open space and natural areas.

4. Focus on establishing a full system of paved and unpaved trails within parks and open space accessible to all areas of the City.

5. Acquire additional property to preserve greenway corridors.

Lastly, this trail tolerance preserves this natural area, notably the nature trail, as frequented by many of the City's deer population. We have reviewed File Number AR PFP 17-00246 for the approval of appropriate zoning to allow the trail from Pioneer Park to Friendship Lane to be deeded to the City of Colorado Springs for safe access/transit between the two locales. <u>https://eoc.springsgov.com/LDRSDocs/LUISPlanner/Documents/App/103201.pdf</u>

Unfortunately we are unable to make the meeting on Sept 21, but it's probably better to convey our thoughts via e-mail anyway.

We have owned our house on Cenotaph Way adjoining Pioneer Park since 1990 and have witnessed the multiple attempts to block traffic via the previously vacant lot, including the cutting, replacing, and re-cutting of chain link fence many, many times, often leaving sharp link fence edges representing an eye and cut hazards to the students transiting the lot.

Make no mistake, this effort is all about the kids in the local neighborhoods around Pioneer Park, including Panorama. It is much safer for them to transit the path enroute to both Holmes Middle and Coronado High Schools. In particular, the alternative of walking up Fontmore on the south side is a terrible slip and fall hazard in winter as ice covers the sidewalk due to fence shade for most of the winter.

Specific comments on appeal:

1. There is no reasonable expectation that there will be an increase in traffic and there may, in fact, be a substantial decrease in vehicular traffic as parents will feel less of a requirement to park on Friendship after school to pick up children if there is a legal access via the path and the park.

2. While the "No Parking, Standing, etc" signs could be extended, thusfar they have not been very effective on the upper end of Friendship. Better to decrease the demand for pick-ups than to hope more signage will be more effective in deterring after-school parking unless the City is willing to bring in police enforcement after school.

3. Neither non-residents of the neighborhood nor loiterers have ever been seen by us in the vicinity of the trail.

4. The argument that an "existing" trail is being relocated is specious as the "previous" trail was illegal and not approved by the property owner nor the City.

5. The arguments about adverse effects of the replat such as increased loitering and unleashed dogs are a real stretch. We always see dogs on the roads surrounding the trail and the park on leashes. Occasionally dogs are off-leash in the park for toss-and-fetch play, but not on pathways, streets, or trails. A trash receptacle on the trail similar to the ones in Pioneer Park serviced and emptied by the City would be a helpful addition and make the litter argument pretty much moot.

6. The new path has been expertly and particularly thoughtfully laid out, fenced and xeriscaped to facilitate maintenance by City Parks & Rec.At considerable personal expense by the applicants, it should be noted.

We strongly urge you to approve the request for the trail and the concomitant zoning/subdivision changes required.
