ORDINANCE NO. 17-85

AN ORDINANCE AMENDING SECTION 407 (MAKE REPORTS) OF PART 4 (POWERS AND DUTIES OF THE CITY ATTORNEY) OF ARTICLE 2 (OFFICERS OF THE CITY) OF CHAPTER 1 (ADMINISTRATION, PERSONNEL AND FINANCE) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO REPORTS TO COUNCIL

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 407 (Make Reports) of Part 4 (Powers and Duties of the City Attorney) of Article 2 (Officers of the City) of Chapter 1 (Administration, Personnel and Finance) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

1.2.407: MAKE REPORTS:

The City Attorney shall immediately report quarterly to City Council, the Mayor, the Risk Manager and as appropriate, the chief executive officers of Utilities or MHS Enterprise, and any other interested staff, the outcome of any litigation and similar legal matters in which the City, Utilities or MHS Enterprise has an interest and shall submit recommendations as to appeal, payment or other disposition in the event of judgment adverse to the City. From time to time Quarterly, the City Attorney shall report all litigation and similar legal matters in which the City has an interest and the status of the litigation.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
