#### **Site Details:**

- 7 acres / 304,920 square feet
- Zoned OC/cr (Office Complex with Conditions of Record)
- Part of the Northgate Master Plan Office-Industrial Park/Research & Dev.
- Vacant, but has already been over-lot graded. The property slopes down from the northeast to southwest.

#### **Public Notification and Involvement:**

- Public notice was mailed to 141 property owners, on two occasions: during the internal review stage and prior to the Planning Commission meeting
- The site was also posted on those two occasions along Oracle Boulevard and Sybilla Lane

#### **CPC ZC 17-00098 – CHANGE OF ZONING TO OC**



Oracle Boulevard Townhomes concept plan for 7 acres of land to be developed with a multi-family residential consisting of 73 townhome units and associated site improvements.






