## ORDINANCE NO. 06- 51

AN ORDINANCE AMENDING SECTION 715 (NUISANCE ABATEMENT ADVISORY COMMITTEE) OF PART 7 (CIVIL ABATEMENT OF NUISANCES) OF ARTICLE 6 (OFFENSES AFFECTING PROPERTY) OF CHAPTER 9 (PUBLIC OFFENSES) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO THE NUISANCE ABATEMENT ADVISORY COMMITTEE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Section 715 (Nuisance Abatement Advisory Committee) of Part 7 (Civil Abatement of Nuisances) of Article 6 (Offenses Affecting Property) of Chapter 9 (Public Offenses) of the Code of the City of Colorado Springs 2001, as amended, is hereby amended to read as follows:

## 9.6.715: Nuisance Abatement Advisory Committee:

A. There is hereby established a Nuisance Abatement Advisory Committee. The Nuisance Abatement Advisory Committee shall oversee the implementation and administration of this part. The Nuisance Abatement Advisory Committee shall meet at least two (2) times annually and on additional occasions, as they members may deem necessary. The Colorado Springs Police Department shall notify the Nuisance Abatement Advisory Committee concerning enforcement actions taken pursuant to this part once notice has been given as provided in section 9.6.704 of this part. The Nuisance Abatement Advisory Committee may make recommendations and reports to City Council concerning this part but shall not have veto or approval authority over the commencement of any action under this part.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.

Modification to §9.6.715: Nuisance Abatement Committee
