- 1.Kiowa Street is a mostly residential street which is part of a larger, historic residential neighborhood andwe want to preserve its residential character. As the applicants' property lies within 200 feet of theresidential area, we ask that planners consider the following points.
- 2. The applicants propose late night hours (until midnight on some nights) which could impact the residentialarea. Therefore, we ask that planners stipulate their business hours extend no later than 10:00pm.
- 3.Crowd noise and car noise are likely to infringe on the residential area especially with an outside patio. We ask planners to stipulate that there is a restriction of no amplified sound on the patio.
- 4. The parking solutions in the application appear adequate and should not affect spill-over onto Kiowa Street.

Regarding the application for non-use waivers by the 13/50 Distillery on Pikes Peak Avenue and the upcoming public meeting, I just want to let you know that the board of directors of the Middle Shooks Run Neighborhood Association are not opposed.

We discussed the issues, spoke to neighbors who live close by, and spoke to the distillery owners. We raised the issues of proposed late hours of operation and exterior noise and feel the distillery owners listened and responded.
