To Whom It May Concern:

My name is Jamie Muth. I'm the Community Organizer with the Independence Center (IC) around affordable and accessible housing. **On behalf of the IC, I would like to express our support of the Ridge.**

With a projected deficit of 26,447 available units at affordable price ranges in 2019 (Affordable Housing Needs Assessment, 2014) and 1,415+ homeless neighbors on our streets as of the 2017 Point in Time (PIT) Count, the City must take a strong stance on this matter. We desperately need the units, far more than even the Ridge will provide.

I have attended some of the Broadmoor Bluff community's meetings about the Ridge. Their opposition is not based on genuine interest in accessibility, safety, or inclusion. Their comments reveal sentiments that are the exact antithesis of inclusion- not wanting "those people" in their community. **NIMBYism is common, unsurprising, and based on fear and misinformation. Do not let it sway you on making the right choice for our community and the future of the City of Colorado Springs.**

As an aside, when considering future affordable developments, the Independence Center urges the City of Colorado Springs City Planning Commission to commit to prioritizing projects that are universally designed. Universally designed housing can be beautiful, accessible, and affordable. Many other cities have embraced this model in their affordable developments, including the Skid Row Housing Trust that presented at the Pike's Peak Continuum of Care's Bi-Annual Conference last fall. Such a model would address our ever-increasing need for affordable, accessible units while also reducing displacement by providing people with a home in which they can age in place.

The Affordable Housing Needs Assessment completed by the City of Colorado Springs and El Paso County in 2014 highlighted the need for accessible, affordable housing in the City and County. At that time, "nearly 60,000 residents in El Paso County h[ad] a disability that could affect their housing situation." Further, the report recognized the reality that with our area's rapidly increasing senior population, there will be a correlating rise in the number of accessible housing units needed. As people with

disabilities tend to be financially vulnerable, the pairing of accessibility and affordability is vital.

Thank you for supporting the Ridge development and an inclusive future for the City of Colorado Springs. Please forward our support to the Commissioners and add this statement to the Ridge's file.

Hannah,

Please include in the public record this letter of support for The Ridge at Broadmoor Bluffs.

Our community needs a variety of housing types and sizes for people with different income levels and lifestyles. When I started as the City's Community Development Manager in 2013, we had no new units of affordable housing in the pipeline for the federal funding the City receives. The staff worked deliberately to raise awareness about the need for affordable housing (Affordable Housing Needs Assessment), to streamline the funding application process, to meet with developers, and to teach service providers how to partner with developers to build housing (Supportive Housing Toolkit series). When I left the City four years later, there were about 500 units in the pipeline.

The Ridge is a solid proposal for well-designed, affordable housing that is compatible with the qualities of the neighborhood, and the developer has asked for no variances or conditions. This is a use by right – a no-brainer for housing development.

Neighborhood opposition to this project is rooted in misunderstanding and antipathy for "those people" who will reside at The Ridge. Growing up in Colorado Springs with a single mom and two brothers, I was one of "those people." And I am proud to say "that woman" raised a successful CEO, Classics Librarian, Real Estate Agent, decent parents and engaged citizens on a retail salary from Payless Shoe Source.

People must be sheltered, and I could go further and cite studies about the links between decent, safe and affordable housing and good health and economic prosperity, but the bottom line here is there is absolutely no reason for the City to deny this application. We shouldn't have to send touching, hand-up-not-hand-out stories and review academic journals to build a narrative to support what is really the entitlement of a private property owner playing entirely by the rules. That message needs to be sent loud and clear.

We can provide safe, decent and affordable in Colorado Springs, and we will be better for it.

I am writing you this letter in support of The Ridge. Colorado Springs has grown at an exponential rate in the last year. Hello, I am writing in support of the approval of the plans submitted by Greccio Housing to build The Ridge. I am speaking as a service provider working with the very low income and homeless population and as a leader of an organization that is a substance abuse treatment provider. Also, I am the Chairperson of the Pikes Peak Continuum of Care. THE PPCOC is a group of stakeholders from City, County staff, business, citizens, service providers and formerly homeless individuals.

This community has a dearth of affordable housing. According to a recent presentation by the HBA on November 17, 2017. The panelists identified that we need over 20,000 of affordable housing for those who earn very low income up through workforce housing (0% AMI to 120% AMI) this project provides housing for the lower end of the spectrum and is vital to move the very low income out of shelters and “doubling up” with other families. This project provides housing for working families who will use this transitional housing program to stabilize their lives, increase their incomes and move to self-sufficiency. These are entry level and hourly workers who may already even work in their area. As a community, we need to support affordable housing built throughout the community. Housing dispersed geographically will provide workforce housing that minimize barriers using public transportation or even reduces personal community time. IT is vital not those who want to live nearby where they work.

Dear Commissioners,

I am sending this email to offer my support to the development of The Ridge. As an advocate for victims and survivors of domestic violence, sexual violence, dating violence and stalking, I understand the critical importance of affordable housing. In order for families to stay safe, they need affordable housing. Domestic Violence is one of the leading causes of homelessness for women and children. This is due to many factors such as economic abuse, gender stratification, poor economy, **and the lack of affordable housing**. In Colorado Springs, over the past two years, I have seen rental companies raise their rent at astronomical rates, leaving victims and survivors fleeing violence in an awful predicament. They cannot find housing that will work for them and their families for a number of reasons: working part-time, even full time, their wages are not enough to meet the requirement of making 2 to 3 times the rent; due to economic abuse they either have poor credit or no credit at all and if they are even considered with poor credit they have to pay a ridiculous security deposit; and due to tactics used by their abuser, they did not have a job when fleeing- which makes obtaining housing and a job simultaneously quite difficult, if not nearly impossible. These are just some predicaments victims and survivors face. Although there are some local resources such as transitional housing programs, they are not nearly enough. Access to affordable housing is not only the right thing to provide, but it is a human right. It is the support people need to create new opportunities for themselves and their families. Access to affordable housing will keep people safe. It is my opinion that we need The Ridge, as we have needed it a while ago. Please take this into consideration.

Dear City Planning Commission and City Council

My name is Martin Leopard and I am a resident and owner of a condo located Las Casas at Broadmoor Bluffs in Colorado Springs. I am writing to both the City Planning Commission and City Council to vehemently oppose the building of the Ridge-Multi Family Housing Project at its current proposed location. I have numerous concerns about the location of this future property as a property owner adjacent to this property and some of which I will outline in this email. I fully support everything outlined in the Broadmoor Bluffs Neighborhood Association appeal filed with the Land Use Review Division on January 2nd, 2018.

I have numerous concerns but I wanted to first highlight the violation of my rights under Federal Consumer Protection laws and my rights under Colorado Common Interest Ownership Act. I was sold my condo under the auspices that this land would be built out as condo development. The approval of the Ridge multi-family development also violates City Code 7.5.504. I am not able to understand how two different governing bodies can approve the building of properties that violate these codified laws that these government bodies either helped create and/or are under direction to follow.

I also want to highlight violations of the American Disabilities Act (ADA) that is recognized by our Federal, State, and City governments. As drawn, this plan lacks access to public streets, bus stops, and it discriminates against the disabled. Also, as resident and a member of the Las Casas condo association, I accept more liability for the pedestrian access to the Ridge project with the 18-wheeled vehicle delivery right-of-way. I do not understand how we can potentially both put citizens at more risk for injury and force the liability on property owners. Secondly, I do not understand how the Commission and City Council can allow the violations of the ADA. This Federal Act has stood the test of time with its initial passing in 1990 to defend the rights of the disabled.

I am confident there are other appropriate pieces of land within the City of Colorado Springs to build this development. Also, the future residents of the Ridge development deserve a safe place to live and reside without the threat of their children getting hit by an 18-wheeler or to access sidewalks that meet the needs of their disability with reasonable accommodations.

Thank you very much for your time and consideration of this matter. I look forward to your responses to my concerns and feedback to the builders of the Ridge-Multi family Housing Project.

With the average rent cost in Colorado Springs at \$1,023, a family would need to earn \$3690/month to fall within housing cost budget guidelines. Dear Commissioners,

I am writing regarding your consideration of “The Ridge” development in Broadmoor Bluffs. Let me start by stating that I am sympathetic to both the needs for low-cost housing and the concerns over local property values and crowding. However, since my home is some distance from the area, I am not personally affected by the project. My concern is relative to the dangerous conditions at the corner of Broadmoor Bluffs and South Academy Blvd. My wife and I both drive and walk through that intersection multiple times every day, and have experienced many near misses, particularly while walking. That intersection takes almost all the traffic from the many neighborhoods along Broadmoor Bluffs. It also is the primary cross street for children going and coming from Pinon Elementary. In the morning, the sun is in the eyes of drivers making left turns onto both South Academy and Broadmoor Bluffs. While walking we have learned to avoid going into the street even with a WALK sign until we see drivers turning left make a positive stop. The crossing guards have all expressed concern for their own safety as well as the children’s safety.

Just before Christmas, after waiting for the left turn cars to stop, we entered the crosswalk with the WALK sign.. Apparently, the driver saw my wife but not me, and accelerated into me after just missing her. The car then sped off and has not been found. I was thrown 20 feet and landed in the street. It is only by the grace of God that I am able to write this letter to you today. When my wife discussed the dangerous condition of the intersection with the city traffic engineer, she was told that with the traffic going through there, the traffic light could not be made safer without unduly slowing the traffic flow. Yet, the proposed project will greatly increase both the vehicle and pedestrian traffic through that intersection. Since the current traffic cannot be handled safely I really question the traffic study results stating that with the increased traffic, the intersection was both safe and could handle the traffic flow.

It is obvious that the near death of a senior citizen at that intersection does not concern the traffic department. I hope it doesn’t take the real death of a child to get someone’s attention.
