AN ORDINANCE AMENDING SECTION 203 (EXPENDITURES FROM FUND) OF PART (CONSERVATION TRUST FUND) OF ARTICLE 6 (CITY CHAPTER FUNDS) OF (ADMINISTRATION. PERSONNEL, AND FINANCE) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO **EXPENDITURES** FROM **CONSERVATION TRUST FUND**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 203 (Expenditures From Fund) of Part 2 (Conservation Trust Fund) of Article 6 (City Funds) of Chapter 1 (Administration, Personnel, And Finance) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

1.6.203: EXPENDITURES FROM FUND:

* * *

- B. Trusts For Specific Purposes:
 - 1. Any monies in this fund held in trust for a specific purpose may be expended only for that specific purpose and no other.
 - 2. Monies may be expended for all purposes consistent with the guidelines specified for the Conservation Trust Fund by the State of Colorado.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this

ordinance be available for inspection and acquisition in the office of the City Clerk.
