AN ORDINANCE AMENDING ORDINANCE NO. 17-116 (2018 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE TRAILS, OPEN SPACE AND PARKS FUND IN THE AMOUNT OF \$139,000 FOR ACQUISITION OF APPROXIMATELY 31.918 ACRES OF PROPERTY AND A PERMANENT ACCESS EASEMENT ACROSS PROPERTY OWNED BY JACOB AND SHANTELL C. SNELL FOR THE PURPOSE OF PUBLIC OPEN SPACE AND TRAILS AS AN EXTENSION OF THE CHEYENNE MOUNTAIN STATE PARK

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Ordinance No. 17-116 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$139,000, inclusive of real estate transaction costs, for acquisition of approximately 31.918 acres of property and a .299 acre permanent access easement across property owned by Jacob and Shantell C. Snell for the purpose of public open space and trails as an extension of Cheyenne Mountain State Park.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
