AN ORDINANCE AMENDING ORDINANCE NO. 17-116 (2018 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE TRAILS, OPEN SPACE AND PARKS FUND IN THE AMOUNT OF \$159,500 FOR ACQUISITION OF APPROXIMATELY 40 ACRES OWNED BY JUSTIN WATKINS AND MELISSA WATKINS FOR THE PURPOSE OF PUBLIC OPEN SPACE AND TRAILS AS AN EXTENSION OF CHEYENNE MOUNTAIN STATE PARK

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 17-116 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$159,500 for acquisition of approximately 40 acres of property owned by Justin Watkins and Melissa Watkins for the purpose of public open space and trails as an extension of Cheyenne Mountain State Park. The source of the funds is the TOPS Fund available Fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
