AN ORDINANCE VACATING PORTIONS OF PUBLIC RIGHT-OF-WAY KNOWN AS CORA LANE LOCATED NORTH OF PALMER PARK BOULEVARD CONSISTING OF .25 ACRES.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. City Council hereby finds, determines and declares that it is in the best interest of the City and its citizens to vacate, and hereby vacates, portions of a public right-of-way known at Cora Lane consisting of .25 acres located North of Palmer Park Boulevard, as described in Exhibit A and illustrated in Exhibit B. This vacation is subject to the retention of public utility and public improvement easements across those areas described in Exhibit A and as illustrated in Exhibit B, attached hereto and made a part hereof, which easements are hereby reserved to the City.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.
