AN ORDINANCE AMENDING SECTION 201 (GENERAL PENALTY) OF PART 2 (GENERAL PENALTY) OF ARTICLE 1 (ADMINISTRATION) OF CHAPTER 1 (ADMINISTRATION, PERSONNEL, AND FINANCE) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO THE PEDESTRIAN SAFETY PROGRAM FUNDING FEE SURCHARGE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 201 (General Penalty) of Part 2 (General Penalty) of Article 1 (Administration) of Chapter 1 (Administration, Personnel, and Finance) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

1.1.201: GENERAL PENALTY:

* * *

F. The pedestrian safety program funding fee imposed by section 10.24.101 of this Code shall be collected by imposing a surcharge, of fifteen dollars (\$15.00), which surcharge shall be imposed in addition to any other fine imposed by this Code.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
