Good Morning Rachel,

I understand that you are still reviewing the preschool expansion on upland road and it is going to another hearing. I probably won't be able to attend the hearing but I did want to offer the updated input I have on possible impacts of the expansion. I will preface this by saying that my daughter is not enrolled at Sarah's school and is not on a waiting list to become enrolled there. A few months after the last hearing, my 1-year old decided her favorite thing in the world is going for a ride around the neighborhood every day in our jeep. As this became at least a daily ritual and sometimes multiple times a day, I realized I was passing Sarah's residence each time we went for a drive, because I found myself honking sometimes as I drove by. Our neighborhood drives usually take place between 2 and 5 pm. I know many of our neighbors had concerns about the traffic impact, and the noise of kids playing outside. I can say that I have yet to see a vehicle stopped in the roadway in front of that address a single time during that timeframe since we began making this a daily ritual. I have also not seen a single child out in front of the house playing or waiting to be picked up. I saw Sarah in front of the house once in the last 6 months. With the uptick in traffic around the broadmoor hotel and the zoo, I did not really want to see any more traffic in our neighborhood than there already is, and at least in my experience, the last 6 months has convinced me that the traffic impact is virtually zero. Noise "pollution" and visibility of the students has been nonexistent. Please feel free to contact me if you have any questions.

Hello Ms. Teixeira:

I am writing to discuss the incredible and wonderful impact Ms. Sarah Forrest's Broadmoor Montessori International School has had on our family and our 3 year old son's learning and social skills. I am aware that a statement like, "finding Sarah has been life changing" is a bit over the top, but believe me, she has truly made such a positive impact on our family that I just had to write a letter to tell you more about her!

Both my husband and I have grueling work schedules; my husband works in the military intelligence field and it's very common for him to work 14 – 15 hour days. I also have my own crazy and ever-changing work schedule which I attempt to juggle with babysitters for my two toddler boys, Ben, age 3, and Oliver, age 1, while working from home.

When Oliver was born just over a year ago, Ben, (who now attends Sarah's school) was incredibly frustrated. He was still too young to talk and really communicate, and he was taking his frustrations out on our new baby. He was "fired" from the Montessori school he had been attending, with remarks from his teacher that he was simply "too intense" and "caused so much distress" to the other children. This was incredibly hard to hear as a parent, let alone parents with a newborn and grueling work schedules.

A friend recommended that we get in touch with Sarah, and our lives changed shortly thereafter when she had an opening for Ben. Upon meeting Sarah, I immediately saw the incredible value she would add to our family, and the value she adds to work from home mothers like myself. I was absolutely floored and just overjoyed when I visited her space for the first time. What an incredibly thought out, meticulously planned and designed area of work space she had! I feel like I had hit the lottery. She had lived abroad several times and had global experience, like myself, and loves to teach the children about Japan and Africa. Amazing, I kept thinking to myself! And she was just such a delight - warm, attentive, caring, and just interesting and incredibly nice and sweet. I remember snapping images of each of the work spaces – a math corner, a language and reading space, a "book nook" for having quiet time and sinking into a book, a whole corner dedicated to painting and art, and an area designated for snack time (with all organic snacks, mind you!). And her outdoor area is a dream, with high fencing and endless activities for youngsters to dig into. And I am not exaggerating when I tell you that I actually sent these cell phone pictures I snapped of her amazing space to all of my friends in Colorado Springs and even Denver, saying "I think I have found the holy grail of teachers / schools."

I knew instantly upon meeting Sarah that this was a perfect fit for us. She has international experience, two Masters degrees, and the warmest, most caring heart of any teacher I've ever met. We tried daycare two years ago and it was not a good fit for us; my son cried by the door every day for two weeks and I watched with horror as one of the daycare workers pushed him in frustration on the "kid cam" in response to his endless crying. Sarah, in contrast, cares immensely for these children and for their success and their ability to learn and absorb and made the remark to me once after a week long summer break that she really missed them and wondered what they were up to. Oh, and as for summer break? "It would be too disruptive for them to take an entire summer off, so I would really like

to continue into summer and have a summer schedule so that learning is not disrupted." I mean, talk about a mother's DREAM!!

My point is that Sarah very seriously wants to see these kids grow and she wants to instill the good values we have at home for them at her school. And she allows me several hours a day to do what I really love to do with my own work, thus giving me a break and allowing me to interact with the outside world and not feel so isolated as a young mother. And I believe this is just invaluable as a new mom; it allows me to be present with my kids and be the best mother I can be while continuing to do what I love to do and have done all my life before doing a 180 and becoming a mother. In casual speak, "she just gets it."

I simply cannot overstate how lucky we feel to have found Sarah. She tells us frequently how much Ben has grown, improved in his social and communication abilities, and how he "really wants to learn" and has made huge leaps and improvements. "He's the poster child for Montessori," she has said to me, when he comes home covered in paint and dirt after a wonderful morning of playing, learning, exploring, and socializing. It just makes me feel so good as a mom! It is just the best situation I could imagine for my child and I cannot wait for his younger brother to join. At drop off, my younger son, now 1, cries when I put him back in the car, because he wants to stay and learn and play as well. He is chomping at the bit to begin with Sarah and is so eager to learn to start!

It saddens me to think that there are neighbors in Sarah's area that oppose her incredible and wonderful efforts at her school simply because cars come in and out of her driveway twice a day. I believe this is a neighborhood of older folks who have probably lived there for a long time, but I hope we can enlighten them on how life-changing a little school like Sarah's can be for both a family like mine and for an entire community of working moms. I know that Sarah herself has made great strides in modifying the traffic patterns to improve this situation. As of now, there is a drop-off and pick-up window of 15 minutes to reduce traffic and parking issues, as well as a "no parking in the road" policy. She also uses of security camera to monitor the pick up and drop off areas, has a parent and / or caregiver escort the child to and from the vehicle. She's even developed a FEMA emergency manual AND the Policies and Procedures has been reviewed and signed by all enrolled families with emphasis on safety and traffic.

I know my family will be absolutely elated when Sarah is awarded this permit allowing for more siblings to attend her school; the critical demand for high quality early childhood education in Colorado Springs is essential. I have built an incredible group of mom friends simply from drop off and pick up at Sarah's school and feel that the benefit and value of in-home care as an alternative to large care facilities is just so critical. She brings community closer together in a way that large care facilities are just not able to do and she fosters an amazing sense of community and warmth in knowing our children are well cared for and learning so much while we work for those several hours a day.

Hi Rachel,

I am reaching out to you in support of Sarah Forrest and the Broadmoor Montessori School. Under consideration is Sarah's application to expand enrollment to 7 -12 children.

My daughter was one of Sarah's first students and still attends Broadmoor Montessori three days a week. My wife and I couldn't be more pleased with the school and our daughter's experiences there. Prior to enrolling her in Broadmoor Montessori, we visited several other schools in Colorado Springs. We've also heard stories from friends whose children attend other schools or daycares, and we have absolutely no regrets about our choice. Broadmoor Montessori provides a quiet, calm environment that emphasizes structure, organization, and creativity and allows our daughter to flourish. Rather than eating microwaved food in front of a TV or running around in a chaotic, screaming mob, our child's daily "work" involves activities such as sitting quietly at her desk arranging items into specific sequences, sorting objects, solving puzzles, and creating art works for mom and dad.

In reading over some of the other comments, the prevailing themes seem to be concerns over traffic, safety, and noise (though generally framed in the hypothetical rather than empirical, despite that the school has been there for something like 2 years now). With regard to increased traffic and safety, as others have pointed out, Sarah has instituted policies and procedures to address this concern. For instance, pickups and drop-offs are staggered so that not everyone arrives at the same time. Also, parking in the street is not permitted and the house has a large driveway that can easily accommodate multiple cars. As for the street itself, the portion leading to Sarah's house is neither steep nor winding--perhaps other segments of Upland are, but I'm unaware as the school is only several houses from the entrance to the street and I don't drive past it.

Another point that bears emphasizing is that a primary purpose of the expansion is to allow for the enrollment of toddler siblings of current students. We also have an 11-month old child and can't wait until she's old enough to join her sister at Ms. Sarah's. Some of the other parents similarly would like to enroll siblings. This doesn't add traffic--we're already driving to the school with two children in carseats, we'd just be leaving two children instead of one. I think it also speaks to the high regard that these professionals have toward Sarah and her school.

I would also like to add that some of the comments about noise seem disingenuous. We've been with Ms. Sarah since the beginning and the school has run from 8:45 am to 1 pm, so complaints about hearing noise late into the night are certainly interesting. Moreover, as I mentioned above, Sarah runs a very quiet, calm ship, which is very much a part of the appeal--our child doesn't bring home behavior problems that she picked up at school. Whatever concerns others on the street may have, I'm willing to bet a simple visit to the school would go a long way toward allaying them.

I am writing to voice my strong support for approving the conditional use for a large daycare at 9 Upland Road. Broadmoor Montessori International fulfills a critical need to provide an accessible and nurturing preschool education for children within our community. My husband, two children and I moved to Colorado Springs from Florida almost two years ago. We feel extremely fortunate to have found Broadmoor Montessori International and Sarah Forrest.

Upon moving to Colorado Springs, I began searching for a preschool program for our daughter. We moved here from a city in Florida that valued high quality preschool programs such as Montessori preschools, bi-lingual immersion preschools and Waldorf preschools, just to name a few. As we are a family that is a proponent of the Montessori preschool program, I began by calling numerous Montessori schools in Colorado Springs. I received responses such as: "Our waiting list is more than a year long." and "We have families that sign their children up for our program at birth so that they will have a space in our program when they turn 3." Her education and training far surpasses any Colorado State requirement for operating an early childhood education facility and this is truly reflected in her teaching. Sarah's students are all eager learners and confident children who will be more than ready for Kindergarten. When I look at her students, I see children that are future leaders in our schools and community.

In addition, Sarah cares deeply about the health and nutrition of her students. Her school participates in the USDA childcare food program through Kids' Nutrition Company and has partnered with the Let's Move Child Care initiative. Therefore, the children are offered highly nutritious foods at snack and lunch and have meaningful active play while they are at school.

On a personal level, I also know that Sarah cares deeply for each individual student. Sarah was instrumental in helping us identify a speech issue that our daughter and provided us with support to help us through the issue. Sarah Forrest and her school are a gift to this community.

I am aware that some of the neighbors are opposed to increasing the child enrollment of the school to a maximum of 12 students. However, their arguments and unsubstantiated. First, the flow of traffic on Upland Road is not impeded during the Monday through Thursday fifteen minute pickup and fifteen minute drop off time. The arrival and departure time of each parent is staggered because of that fifteen minute window. In addition, all parents are aware that the driveway accommodates six cars, the parent must escort the child(ren) by the hand while in the driveway and that we cannot park/wait on the street. The Policies and Procedures document that the parents sign when we enroll our child(ren) in the school clearly states this. Sarah also provides the parents with frequent reminders both verbally and via text message regarding the drop off/pickup guidelines.

Second, the wildlife threat to child safety on Upland Road is no different from any other local school or daycare in that area. I have a son that attends the Colorado Springs School that encounters the same wildlife as the homes on Upland Road. To be prepared, Sarah conducts frequent wildlife emergency drills with her students. She has also gone above and beyond by installing motion detection surveillance cameras that alert directly to her cell phone if wildlife is present around the house.

Third, it is incomprehensible that neighbors would complain about a maximum of 12 children playing outside for a one hour period at noon time. The outdoor space is located at the back of the house and is completely fenced with very mature trees and shrubbery.

Finally, the complaint that a school/daycare in the neighborhood will bring down housing prices is entirely unsupported. In fact, as the older generation of homeowners leave the neighborhood Broadmoor International

Montessori will be seen as an asset, especially by families with young children. I would also argue that a small business such as this aligns directly with the City of Colorado Springs' vision for PlanCOS. Broadmoor International Montessori promotes the vision of PlanCOS' following statements:

- (1) "...a city of neighborhoods with affordable house, walkable destinations, convenient parks, and quality schools."
- (2) "Establishes positive connections between different land uses and achieves a well designed balance between their location and mix, encourages innovation and creativity in development and the creation of an aesthetically appealing community."
- (3) "Successfully integrates the uses and activities that meet the daily needs of residents, including housing, shops, work places, schools, parks, and civic facilities."

I urge you to vote to approve the conditional use for a large daycare center at 9 Upland Road. Our community is in dire need of more accessibility to quality early childhood education programs at Broadmoor International Montessori by Sarah Forrest. I know Sarah will continue to be vigilant and proactive regarding the perceived traffic and safety issues of the few still concerned in her neighborhood. Broadmoor International Montessori fits strongly into the vision of PlanCOS and is an asset to our community.
