ORDINANCE NO. 18-96

AN ORDINANCE AMENDING ORDINANCE NO. 17-116 (2018 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE AIRPORT CAPITAL IMPROVEMENT PROGRAM FUND IN THE AMOUNT OF \$2,500,000 FOR CASUALTY REPAIRS RELATED TO THE APRIL 2018 FIRE AT THE COLORADO SPRINGS AIRPORT TERMINAL BUILDING

WHEREAS, the Colorado Springs Airport terminal building was damaged by fire on April 16, 2018; and

WHEREAS, an emergency supplemental appropriation to the Airport Capital Improvement Fund in the amount of \$5,000,000 was approved by City Council on April 24, 2018; and

WHEREAS, the scope of demolition and repairs is greater than initially anticipated based on estimates that were completed during the two weeks following the fire; and

WHEREAS, the Colorado Springs Airport requests the approval of a supplemental appropriation in the amount of \$2,500,000 to complete the needed demolition and repairs, fully reimbursed by insurance proceeds.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 17-116 is hereby amended by increasing the Airport Capital Improvement Program Fund revenue and expenditure appropriation in the amount of \$2,500,000 for repairs related to the April 2018 fire at the Colorado Springs Airport. The source of funds is insurance proceeds related to the fire.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
