We are writing to express our opposition to the building of another house on the lot at 28 Polo Drive. There are several reasons why we are opposed:

- 1. The one new house already built on this lot does not fit in with the rest of the neighborhood. It is virtually 3 stories high; all of the other homes located nearby are only one to two stories.
- 2. A large part of the lot at 28 Polo, especially in the rear, is actually part of a landslide, and slopes downward quite significantly.
