NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 101 (Mayor and Council; Departments) of Part 1 (Elective Officers) of Article 2 (Officers of The City) of Chapter 1 (Administration, Personnel, and Finance) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

1.2.101: MAYOR AND COUNCIL: DEPARTMENTS:

- B. In performance of its duties required by City Charter, the City Council shall provide its strategic plan and goals, and its Annual Report to the Citizens, to the Mayor no later than the first Monday in April June 30 for the Mayor's consideration in the development of the Municipal administrative budget.
- Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.
- Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
