AN ORDINANCE AMENDING ORDINANCE NO. 18-118 (2019 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE GENERAL FUND UP TO THE AMOUNT OF \$2,400,00 FOR A TRANSFER TO THE CAPITAL IMPROVEMENT PROGRAM FUND, AND TO THE CAPITAL IMPROVEMENT PROGRAM FUND UP TO THE AMOUNT OF \$2,400,000 FOR CAPITAL TRANSPORTATION INFRASTRUCTURE PROJECTS DUE TO ADDITIONAL FUNDING FROM THE HIGHWAY USERS TAX FUND

WHEREAS, due to SB 19-262, a one-time transfer of State General Fund dollars to the Highway Users Tax Fund (HUTF), the City will receive additional funding in 2019 from the Highway Users Tax Fund up to the amount of \$2,400,000; and

WHEREAS, the funding from HUTF must be spent on transportation projects; and

WHEREAS, the projects listed in Section 2 are critical infrastructure needs in the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 18-118 is hereby amended by increasing the General Fund revenue and expenditure appropriation up to the amount of \$2,400,000 to transfer funds to the Capital Improvement Program (CIP) fund. The source of funds is additional funding from the Highway Users Tax Fund (HUTF) due to SB 19-262.

Section 2. That Ordinance No. 18-118 is hereby amended by increasing the CIP Fund revenue and expenditure appropriation up to the amount of \$2,400,000 for capital transportation infrastructure projects. The source of funds is a transfer from the General Fund, as stated in Section 1. The following projects would be funded in 2019:

Peterson Air Force Base East Gate for up to \$150,000 Wooten Road over Sand Creek Bridge for up to \$1,350,000 Paseo Street Bridge for up to \$450,000 Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
