

A public notice poster has been prepared for the Applicant to pick up from the City Clerk's Office at 30 S. Nevada Avenue, Suite 101. This notice poster must be posted by the Applicant at the proposed premises in a manner that is visible and conspicuous to the public no later than **Tuesday**, **June 11**, **2019**. INITIAL FINDINGS OF FACT

- I. 
Liquor Survey Boundaries
