Ms. Van Nimwegen,

I just found out today that there is a proposal to put in 36 home in the Springs Ranch subdivision, named Pony Park Residences.

I would like to state this project would not be good for Springs Ranch or students (and parents) going to Remington Middle School.

I not 100% sure, but I believe there are 700+ (most likely more) homes in the area surrounded by Constitution, North Carefree Circle, Peterson Rd, and Sand Creek open area. There are <u>only three street exits</u> for residences in this subdivision of 700+ homes; Piros Dr, Pony Tracks Dr (North exit and South exit). Adding more homes/residents would just add to the already existing traffic congestion. The exit nearest to this proposed development does not even have a turn lane and is controlled by a traffic signal.

In addition, Pony Tracks Dr (from Peterson Rd to Flying Horse Rd) and Flying Horse Rd (from Pony Tracks to Quarter Circle Rd) are complete full, overwhelmed in fact, with vehicles and parents picking up their children from Remington Elementary School (across the street from Springs Ranch Park). This area is a traffic "jam" in the morning (school drop off) and in the afternoon (school pick up).

I'm asking that this proposal/request be denied. Additional cars and associated traffic would only increase the already existing traffic congestion problem. With only three exits routes from the subdivision, and a large elementary school in the immediate vicinity, this change just doesn't make sense and would negatively impact the current residents of Springs Ranch and parents of Remington Elementary School students.

I encourage someone from the city to come to the intersection of Peterson Rd and Pony Tracks Dr in the morning just prior to school starting, and in the afternoon when school is released to see first hand how bad the current traffic situation is.
