A RESOLUTION FIXING AND CERTIFYING THE 2015 TAX LEVY FOR TAXES PAYABLE IN 2016 AT \$1.10 PER FRONT FOOTAGE OF REAL PROPERTY OF ASSESSED VALUATION WITHIN THE PLATTE AVENUE SPECIAL IMPROVEMENT MAINTENANCE DISTRICT

Section 1. That the City Council determines the amount of money raised by the tax levy for the Platte Avenue Special Improvement Maintenance District (District) for the ensuing year is the sum of \$8,672.

Section 2. That for the purpose of maintaining and securing the public improvements included in the District, a tax levy for the Year 2015 shall be fixed at \$1.10 per front foot of real property of assessed valuation of property within the District for collection in 2016.

Section 3. That the City Clerk is directed to certify a copy of this resolution to the Board of El Paso County Commissioners in accordance with Section 3-7-108 of the Code of the City of Colorado Springs 2001, as amended.


