How are Drainage Fees Determined?

Each Drainage Basin has a master drainage study called a **Drainage Basin Planning Study** ("DBPS")

Public Facilities cost estimate ÷ total acres available for platting = **Per Acre Fee**

Example: Bear Creek DBPS (1980) original fee calculated at \$1,000 per acre (2016 fee = \$3,391)

Who Pays Drainage Fees?

- Subdividers at the time of platting
- Example: Ten acres in XYZ basin at \$10,000 per acre = \$100,000 fee obligation.



Do all Subdivider Pay Drainage Fees?

Yes. However there are ways other than a cash payment to satisfy the fee requirement

The fee obligation may be offset by constructing public drainage facilities; and

Developers may use "Reimbursement Credits" in a drainage basin to cover cash fees due.



Example 1: Ten acres at \$10,000 per acre = \$100,000 fee obligation and no public facility construction costs to offset the fees.

This subdivider pays \$100,000 in fees

Example 2: Ten acres at \$10,000 per acre = \$100,000 fee obligation. Public Facilities cost the subdivider \$25,000.

This subdivider pays \$75,000 in cash for drainage fees.



Who is Owed Reimbursement from the Basin Fund?

Subdividers who construct public facilities costing more than the fee obligation for their specific plat.

Example: Ten acres @\$10,000 per acre = \$100,000 Fee obligation. Subdivider constructs facilities costing \$150,000.

This subdivider is eligible for a \$50,000 reimbursement.



CITY CODE:

7.7.902: Studies of Drainage Basins:

Prior to January 1 of each year the unit drainage fee and the unit detention reservoir land fee shall be reviewed by the Drainage Board who shall make a recommendation to the City Council as to any adjustment to the fees. Upon such recommendation the City Council shall establish by resolution the unit drainage fee and the unit detention reservoir land fee in each drainage basin to be effective January 1 of each year. Said fees will be reestablished in accord with changes in construction and other costs or revisions suggested by additional studies or other information obtained. (Ord. 96-44; Ord. 01-42; Ord. 02-130; Ord. 08-44; Ord. 11-19)



Stakeholder process

Staff recommended a 7.3% increase which included a correction based on the Denver/Boulder/Greeley CPI.

- 1.3% from the 2014 projection of 1.5% (actual was 2.8%)
- 3.5% adjustment for 2015 and
- A projected adjustment of 2.5% for 2016.



Stakeholder process

After meeting with City staff, the HBA made presentations at the February 4, 2016 and March 3, 2016 City/County Drainage Board meetings.

City/County Drainage Board considered the recommendation made by the HBA to eliminate the projected CPI increase of 2.5% for 2016.

The City/County Drainage Board voted to adjust the Drainage fee by 4.8%.
