


RESOLUTION NO. _____

A RESOLUTION SETTING THE GAS COST ADJUSTMENT EFFECTIVE NOVEMBER 1, 2016

WHEREAS, through Resolution No. 261-04, dated November 23, 2004, City Council directed that the Gas Cost Adjustment could be determined as frequently as monthly to levelize revenue recovery and minimize the fluctuations associated with less frequent adjustments during periods of price volatility; and

WHEREAS, through Resolution No. 77-16, City Council set the Gas Cost Adjustment at \$0.1368 per Ccf on July 26, 2016 to be effective August 1, 2016; and

WHEREAS, Colorado Springs Utilities has prepared projections of costs and revenues in conformance with the language in the GCA tariff; and

WHEREAS, Colorado Springs Utilities has shown that a Gas Cost Adjustment rate of \$0.1368 per Ccf should be adjusted to \$0.1815 per Ccf in order to represent the current state of natural gas system revenue needs and that the Gas Cost Adjustment shall be revised accordingly; and

WHEREAS, the proposed Gas Cost Adjustment rate shall be effective November 1, 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Colorado Springs Utilities Tariff, City Council Volume No. 5, Natural Gas Rate Schedules shall be revised as follows:

Section 2. The Gas Cost Adjustment rate and the effective date shall be published in the legal section of a newspaper of general circulation in Colorado Springs Utilities' service area within ten (10) days following the date of the passage of this Resolution.

Section 3. The attached tariff sheet is hereby approved and adopted effective November 1, 2016 and shall remain in effect unless changed by subsequent Resolution of the City Council.

GCA ALTERNATIVE 2:

- Postpones quarterly adjustment until January 2017 filing - Proposed GCA rate increase from \$0.1368 to \$0.2550 eff. 02/1/17: • Res = \$7.09; 19.5% • Com = \$146.57; 28.3% • Ind = \$1,465.68; 31.4% - Postpones but increases future bill impact - Delayed alignment of GCA rate with cost per Ccf - Risk of under collection being out of Band in January 2017
