The dome provides not only winter training, but also consistent and reliable training and racing opportunities throughout the year. Afternoon thunderstorms cancel training and racing regularly in the summer. As a coach of the local junior cycling team, we have seen a dramatic increase in the number of juniors at the velodrome and a huge improvement in results at the national level.

I am a local junior who has been riding the track and being a part of the community for years. The track is a great facility but the dome makes it so much better. Being able to consistently train and race is fantastic and helps improve the abilities of all the riders significantly. The junior program is largely improved by the dome because more families notice it and join the sport. Since the dome went up the umber of active kids has increased greatly, which is important to continue.

As a community member who trains on the velodrome, I appreciate the consistency of being able to train year round. As a certified USAC coach who works with a junior cycling team, this facility is invaluable; it is a safe controlled environment. We have a group of juniors who can train and be competitive at a national and international level. There are so many positives to having the velodrome covered it won't all fit here. Additionally, it is a unique tourist attraction-I have certainly coached many out of towners through a ride the velo experience.

The velodrome has brought many benefits to our city including increased training opportunities for our Olympic & Paralympic athletes, community users, military veterans, and international athletes that have chosen COS as their training home because of the velodrome year-round use. In addition, Team USA won 2 Olympic medals in the track cycling as well as the 1st-ever world championship win in the team pursuit for the United States.

This dome has had an incredibly positive impact not me and my cycling team of 40 members, most of whom travel 1.5-3 hours for the reliability of the training year-round. I believe the potential for the dome is high and full impact has yet to be seen.

I can't fully express how important this track is and having a permanent dome is key to keeping it viable. There is no downside and a huge upside.

Having the dome up in the summer will allow Team USA athletes to prepare for Tokyo Olympics at altitude, which is essential for optimal preparation. If it is down, weather risk may force the team to go elsewhere + lose altitude benefit. Permanency is essential to optimizing its use for preparing our Olympians.

USA needs the velodrome covered to stay competitive at the world level and it's a great way to introduce people to the sport in a safe way.


Allows people w/jobs to train and compete by having it open at night and year-round.







