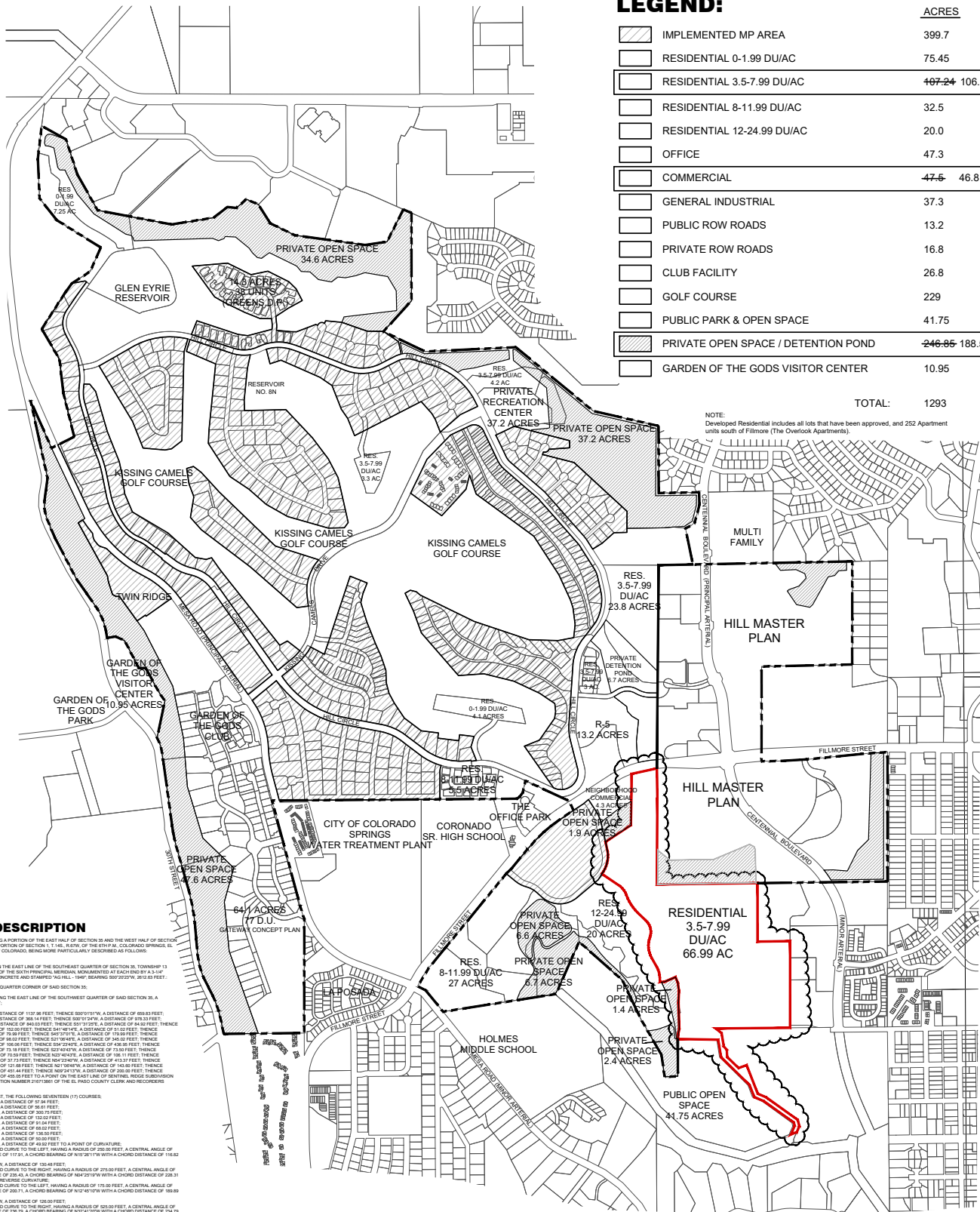

LEGAL DESCRIPTION

A PARCEL OF LAND, BEING A PORTION OF THE EAST HALF OF SECTION 26 AND THE WEST HALF OF SECTION 26, T13S, R10E, AND A PORTION OF SECTION 1, T14S, R10E, OF THE ORIGINAL COLORADO SPRINGS, 36 PARCELSITY 2716 OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BASE OR BEARING: BEARINGS ARE BASED ON THE EAST LINE OF THE SOUTHWEST QUARTER OF SECTION 26, TOWNSHIP 13 SOUTH, RANGE 10 WEST OF THE 37TH MERIDIAN, ARIZONA INSTRUMENTS AT EACH END BY A 1/4" ALUMINUM CAP SET IN CONCRETE AND STAMPED "763 1661 - 1947" BEARING 76°32'27.0" E, 261.03 FEET.

15. THENCE ALONG SAID CURVE TO THE LEFT, HAVING A RADIUS OF 225.00 FEET, A CENTRAL ANGLE OF 30°40'00" A DISTANCE OF 158.84 CHORD BEARING OF N10°18'19" WITH A CHORD DISTANCE OF 164.43 FEET;
16. THENCE N02°30'30" A DISTANCE OF 200.10 FEET TO A POINT ON THE EAST LINE OF GRAND VISTA PLUMB NUMBER 148 RECORDED AT RECEPTION NUMBER 8924842 OF THE EL PASO COUNTY CLERK AND RECORDS OFFICE AND A NON-TANGENT POINT OF CURVATURE;
17. THENCE ALONG SAID EAST LINE AND CURVE TO THE LEFT, HAVING A RADIUS OF 330.00 FEET, A CENTRAL ANGLE OF 41°10'00" A DISTANCE OF 300.00 CHORD BEARING OF N11°10'30" WITH A CHORD DISTANCE OF 258.81 FEET;
18. THENCE CONTINUING ALONG SAID EAST LINE N11°10'30" A DISTANCE OF 17.94 FEET TO A POINT ON THE SOUTHERLY LINE OF FALGOUTS APARTMENTS SUBDIVISION AS RECORDED AT RECEPTION NUMBER 3191411 OF THE EL PASO COUNTY CLERK AND RECORDS OFFICE;
19. THENCE ALONG SAID SOUTHERLY LINE N08°20'30" A DISTANCE OF 30.00 FEET;
20. THENCE N07°20'30" ALONG THE EASTERLY LINE OF SAID FALGOUTS APARTMENTS SUBDIVISION, A DISTANCE OF 580.31 FEET TO A POINT ON THE SOUTHERLY RIGHT OF WAY LINE OF FLAGLER STREET AND A NON-TANGENT POINT OF CURVATURE;
21. THENCE ALONG SAID CURVE TO THE RIGHT, HAVING A RADIUS OF 500.00 FEET, A CENTRAL ANGLE OF 16°52'00" A DISTANCE OF 291.74 CHORD BEARING OF N07°19'19" WITH A CHORD DISTANCE OF 268.89 FEET;
22. THENCE CONTINUING ALONG SAID SOUTHERLY LINE N08°19'45" A DISTANCE OF 12.37 FEET TO A POINT ON THE EAST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 26;
23. THENCE ALONG SAID EAST LINE, S07°20'30" A DISTANCE OF 330.41 FEET; TO THE POINT OF BEGINNING.

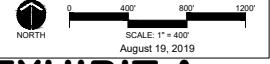
