Council Administrator) is repealed and the annual salary of the City Council Administrator

is set at \$103,584, together with applicable benefits, effective December 28, 2019.

Section 3. This ordinance supersedes all prior ordinances that are inconsistent

herewith to the extent such prescribed the salary of the City Council Administrator.

Section 4. This ordinance shall be in full force and effect from and after its final

adoption and publication as provided by charter.

Section 5. Council deems it appropriate that this ordinance be published by title

and summary prepared by the City Clerk and that this ordinance shall be available for

inspection and acquisition in the office of the City Clerk.
