



What is a puppy mill?

A puppy mill is an inhumane, large scale breeding facility where profit is more important that the welfare of the dogs. Females are bred heat after heat until their bodies can no longer withstand the abuse. Puppy mill dogs are forced to spend their entire lives in cramped cages, stacked one on top of the other, never knowing the feeling of grass under their paws.

Puppy mills are vastly different from reputable breeders who take care of the adult dogs and do the proper genetic tests to ensure healthy puppies are being produced and sold.

Puppy Mill Statistics

10,000: Estimated number of puppy mills in the U.S. (both licensed and unlicensed).

1,902: Number of USDA Class A and B licensed facilities that breed dogs for the pet trade.

165,474: Estimated number of dogs kept solely for breeding purposes in USDA licensed facilities.

107,558: Estimated number of female dogs kept for breeding at USDA licensed facilities.

1,011,046: Estimated number of puppies produced by USDA licensed facilities each year.

2.02 million: Estimated number of puppies sold annually who originated from puppy mills – USDA licensed and non-USDA licensed.

30: The approximate number of active puppy mills in Colorado.

2: The number of times that Colorado puppy mills have been named as the worst in the country.

Puppy mills are **LEGAL**. This is a common misconception among the general public. Puppy mills sell their puppies in pet stores, the newspaper or on websites that ship straight to your home.

Puppy Mill Puppy Facts

- -Dogs from puppy mills are prone to many congenital and heredity conditions due to conditions that the parents and puppies are forced to live in.
- -The dogs being bred in puppy mills are not OFA (Orthopedic Foundation for Animals) tested. Dogs with poor OFA ratings would never be bred by a reputable breeder.
- -Puppy mill puppies show an increased prevalence for behavioral problems as an adult as they do not receive the necessary human contact and socialization that is so critical when a puppy is between 3-16 weeks of age. Puppy mill puppies are often removed from their mother and litter mates at just 6 weeks old.

While the problem of unethical breeders has become a national problem, the solution must be addressed at the local level.

Enforcement standards should be applied in each state that has laws governing commercial breeding operations. Loopholes can be closed by states enforcing the current laws that presently exist, and providing new laws that enable the public to be knowledgeable about legitimate breeders operating within the state. Without overstepping their boundaries, states can provide clear expectation and standards for facilities that operate as commercial kennels, and allow those legitimate breeders to prosper in the production of healthy puppies.

Below is a list of the worst commercial dog breeders that Pet City Chapel Hill and Pet City Baja are sourcing from. **These breeders are still licensed and breeding, without consequence.**

All of this data comes from the Colorado's own PACFA and the USDA. These breeders are currently being used as of April 2019.

Lorilee Thomas, Puppies Extraordinaire. Whiting, Kansas- 642 adult breeding dogs and 288 puppies with a history of violations including: dogs with hair loss, wires poking into kennels, excessively long toe nails, evidence of mice, etc.

HOUSING FACILITIES, GENERAL.

(a) Structure; construction. Housing facilities for dogs and cats must be designed and constructed so that they are structurally sound. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

The viryl coated expanded metal flooring in two enclosures do not completely cover the enclosure. There is an estimated one to two inch gap that exists next to the flooring. Two dogs are in contact with the affected areas which are located in shelter housing. This affects the ability of the flooring to contain the dogs securely and could lead to potential injury. The licensee must ensure all enclosure flooring is kept in good repair to protect the dog from injury and contain the dog securely at all times. Correct by 8/19/13.

 An estimated one to two inch gap exists between the divider fencing and enclosure flooring in two enclosures. The metal clips used to secure the fencing have torn through the bottom of the divider fencing thus creating the gaps. Six dogs are in contact with the affected area which is located in shelter housing. This affects the ability of the enclosure fencing to contain the dogs securely and could lead to potential injury. The licensee must ensure all enclosure fencing and flooring is kept in good repair to protect the dog from injury and contain the dog securely at all times. Correct by 8/19/13.

(c) Surfaces--(1) General requirements. structural strength of the surface.

- Excessive rust, jagged holes and a roughened surface were observed along the bottom of one galvanived pipe divider frame. Four dogs are in contact with the affected pipe frame which is located in indoor housing. In addition, the middle support pipe is showing excessive rust where it connects to the bottom pipe. Rust can erode and deteriorate all metal surfaces to the point that the metal surfaces can no longer be readily cleaned and sanitized. Excessive rust affects the structural integrity of all metal surfaces. Licensee must ensure that this and all other surfaces are free of rust and of good structural strength. Correct by 9/5/13.
- * The facility inspection and verbal exit briefing done on 8/5/13 and the exit briefing conducted on 8/8/13 were conducted with the licensee.

Pam Wilson, Gallatin Missouri- Wilson runs one of the worst puppy mills in the entire country with a history of violations including: issues with unsafe housing, inadequate cleaning, unsafe animal handling, lack of proper veterinary care and the breeder admitting to using cattle prods on the dogs.

Gallatin, Missouri: Pam Wilson - Admitted using a cattle prod to break up dog fights: direct violation for puppy with crusty scabs and other dogs with similar issues; licensee admitted she caught a rash from the dogs, yet none of the animals with skin disorders had been seen by a veterinarian. In June 2017, a Missouri state inspector found nine violations at Pam Wilson's kennel, including issues with unsafe housing, inadequate cleaning, unsafe animal handling and lack of proper veterinary care. Two separate veterinary care issues were cited, including one "direct" violation for a French bulldog puppy who had scabs and crusty areas from her neck to her midline (spine). According to the licensee, multiple other dogs had similar lesions and she had apparently "develop[ed] itchy rashes herself after handling some of the dogs." None of these dogs had been seen by their veterinarian at the time of inspection for the issues, which could be caused by scabies or other parasites. The inspector also noted that there was no current program of veterinary care available. Other violations noted at this inspection included a cattle prod found in one of the rooms that the licensee claimed she used to break up dog fights. The inspection report stated, "The licensee shall immediately discontinue use of any non-species appropriate training/management equipment to prevent unnecessary injury, stress, or trauma to the animals." Other concerns noted at this inspection were about "20 exposed power outlets" accessible to the dogs and puppies in the licensee's house, among other issues.

Marvin and Rosemary Mullet, Clover Ridge Kennel LLC, AKA RosenMarv Kennels. Corydon, Iowa- 85 adult breeding dogs. Violations including: kennels not impervious to moisture. This breeder also cancelled their former license (RosenMarv Kennels) and started this new one in order to hide their long list of violations including: dogs with cloudy eyes, rusted kennels, expired medications used on dogs, medications not meant for dogs being used on them.

Dog Broker with a history of violations, including using pig medications on puppies. * A dog broker is a company that acts as a middle-man. They buy puppies from commercial breeders and sells them to pet stores, so the name of the breeders are left off of the paperwork. Below you will find a list of puppy mills that Busboom sources from.

All of this data comes from the Nebraska Department of Agriculture and the USDA. These breeders are currently being used as of April 2019.

AG Beukelman, J Michaels Kennels. Sioux Center, Iowa- 95 adult breeding dogs, with a history of violations including: excessively rusted cages, wires broken and poking into kennels, build up of dirt/grime, excessively chewed bowls, dogs withuntreated eye problems, and dead mice found floating in dogs' drinking water. Although Beukelman is a veterinarian himself, he is known as one of the worst puppy mills in the country.


Julie Nelson, Nelson Farms. Fairfield, Iowa- 75 adult breeding dogs with a history of violations including: very sick Shih-tzus, not having a veterinarian on site for over a year, and having severely chewed/jagged water bowls.

Dave Ruter, Sioux Center, Iowa- 55 adult breeding dogs with a history of violations including: Excessively rusty doors/cages, filthy kennels, excessively chewedwalls, unsafe kennels.

Gary and Elaine Vande Weerd, Vande Weerd Kennels. Sioux Center, Iowa- 27 adult breeding dogs.

Gary Felts, Black Diamond Kennel. Kingsley, Iowa- 183 adult breeding dogs (before he auctioned them all off) with a long history of violations including: dogs noted with eye issues, excessively rusty kennels/cages, metal feeders/waterers that are rusted, exposed screws in kennels, excessively chewed wood, standing water in buildings, no wind/rain break, excessive feces in whelping rooms, "Records on hand" not completed, severely rusted pens, excessively chewed pens, dust/dirt/debris/grime buildup in pens, sharp points in all of the kennels, big holes in the floors (dogs legs are passing through, even bodies). The USDA put him on a 3 year

probation in 2016, and Felts was named one of the worst puppy mills in the country in 2017, 2016, 2015 and 2013.



Helen and Scott Ketelsen, Hull lowa- 129 adult breeding dogs.

Tara Hansen, Doon lowa- unable to access records.

Pam Habbinga, Habbinga Kennels. Boyden, lowa- 111 adult breeding dogs with violations including: cracked cement in kennels that cannot be cleaned or sanitized.

Tabitha Bakker, Hawarden Iowa- unable to access records.

Heidi or Megan Johnston, Murray Iowa- unable to access records.

Judy and Steve Thiesse, TZ Kennel. Mitchell, South Dakota- 21 adult breeding dogs with a history of violations including: Rusted wire and tin poking into dog kennels and run areas.

Nancy Ogle, Irene South Dakota- 51 adult breeding dogs (down from 85) and close to 100 puppies on site, with a history of violations including: missed inspections, filthy kennel conditions, dogs in need of veterinary care, dogs with eye issues, dogs with dental disease, and excessive brown grime in kennels. Ogle was named one of the worst puppy mills in the country in 2017.

Pat Crabtree, Crabtree Kennels. Saint Francis, Kansas- 195 adult breeding dogs with a history of violations including: not having puppies vaccinated for dangerous diseases, dogs with severe dental disease, dogs with eye issues, dogs with ear infections and wounds on their body. Crabtree was also named one of the worst puppy mills in 2015 and 2014 and has a history of changing her license number to hide from her violations.

Cindy Sherlock, Furry Friends Kennel. St Francis, Kansas- 40 adult breeding dogs.

Tom Vaassen, Lancaster Wisconsin- 22 adult breeding dogs.

Jeanna Johnston, Coalgate Oklahoma- unable to access dog records.

The list of commercial breeders that Colorado pet stores are using is long and it is full of violations. The fact of the matter is, reputable breeders will never sell their puppies in pet stores.

It is up to the city of Colorado Springs to protect its citizens and consumers from purchasing sick puppies. Below you will find real reviews from people in your city.

I bought a sick puppy from this store about a year ago. They told me she had a minor cold and that it would go away soon with more medicine. The illness never went away unfortunately so she is still on medication a year later.

Pet City did help pay for medical bills for a few months after I purchased the dog but I am still left with having purchased a permanently ill dog for almost \$2,000 and I continue to pay out about \$300 per Vet visit.

I asked Pet City for a partial refund to help cover medical expenses and they denied my request. They offered to let me swap the dog out with a different puppy. By this time we had already built a connection with the dog and honestly I didn't like the idea of returning a sick dog that may never get resold and end up being euthanized.

I was told by many Vets that the dog was likely not transported with care as well as being exposed to unhealthy and stressful environments. Therefore I would not recommend purchasing a pet through Pet City. I had plans for my dog to be a service animal and potentially even breed in the future. Obviously this was a lot less likely with her illnesses and I now have to dedicate more time and money than anticipated for this dog to live a somewhat normal life.

Also recently I noticed the dog had 3 bumps forming on the back of her neck. After X-Rays it was determined that she was not properly microchiped and that the chip was moving around and would eventually come out. This has caused a lot of pain for the poor dog and she continues to scratch it.

The pet store owners know it, the employees might know it - but the customer is completely in the dark.

As shown above, the Pet City Website claims that they use "licensed, reputable breeders." Our research has determined that is a lie. Sadly, Pet City doesn't seem to be that picky with where their puppies are coming from at all. As you will read below, every location of Pet City is connected to large scale puppy mills, many with severe violations and even a few that have been listed on the "Horrible Hundred Puppy Mill List".
