Wynetta Massey, City Attorney, stated the Ordinance was revised as requested by Councilmember Williams at the April 27, 2020 City Council Work Session meeting

Councilmember Pico stated he is opposed to this amendment.

Councilmember Gaebler stated the downtown businesses need this change so that patrons will utilize the parking garages and not spend large amounts of time at the meters.

Councilmember Avila stated in order for the City to honor the sacredness of family, there should not be parking charged on Sundays.

Councilmember Geislinger stated the proposed circulator bus planned for the downtown area would benefit the City and the downtown parking situation.

Joshua Pace, Senior Contracting Specialist, Office of Sustainability, gave an overview of the amendments in the City Code for wireless communication facilities (WCF) and small cell facilities.

Morgan Hester, Principal Planner, Land Use Review, presented the details of the Ordinances amending Chapter 7 of City Code establishing standards and revising all references for WCF from Commercial Mobile Radio Service (CMRS), including small cell facilities, and establishing standards specific to modifications of macro cellular communication sites on private property, in accordance with Federal regulations. Ms. Hester also presented the Ordinance amending Chapter 3 of City Code establishing the allowance of small cell facilities in the right-of-way.

Councilmember Murray requested standards be set requiring initial and annual testing regarding radiation output levels. Ben Bolinger, Senior Attorney, Office of the City Attorney, stated municipal jurisdictions do not have authority over radio frequencies and wireless facility emissions and they are generally exempt from testing. Councilmember Pico stated the Federal Communications Commission (FCC) already requires a certain amount of standards and testing in their licensing and certification. He and Councilmember Murray stated they believe a copy of the paperwork submitted to the FCC should be also be required to be submitted to the City with the site application.

Councilmember Geislinger asked what authority the City has over standards required for small cell facilities. Mr. Bolinger stated aesthetics and siting. Mr. Bolinger stated if the City tested on their own, they could report any violations to the FCC, but that would be the extent of their authority over it.

Councilmember Williams asked what the cost would be for testing. Councilmember Murray stated he believes it would be a minimal expense to the provider. Ms. Hester stated she will reach out to the provider for additional information.

President Skorman asked if these towers degrade over time. Councilmember Pico stated damage to the tower would not cause an increase in the power output.

Councilmember Avila asked if these Ordinances are to ensure alignment with the FCC. Ms. Hester confirmed they were along with requirements for aesthetics and siting.

Councilmember Murray asked how much wattage is emitted from these towers. Councilmember Pico explained they generally emit between 10-100 watts.

Councilmember Williams asked if the provision requiring a copy of the paperwork submitted to the FCC could be added to City Code Section 7.4.606(A)(3). Mr. Bolinger stated they will make that amendment and also correct the definitional language in the Ordinance.
