AN ORDINANCE AMENDING ORDINANCE NO. 19-87 (2020 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE PARKING ENTERPRISE FUND IN THE AMOUNT OF \$1,100,000 FOR ADDITIONAL FUNDING OF SMART TECHNOLOGY PARKING METERS
