As many of you may know I'm appealing the split decision by the City Planning Commission regarding the appeal by the residents at 17 Marland to uphold the non-use variance granted by the City of Colorado Springs. Nancy,

Thank you for the letter. I want to make you aware that I did receive a non-use variance from the city for the height of my fence. This non-use variance was appealed and the city planning commission upheld the appeal by a 4-3 vote. I'm in the process of appealing the planning commission's decision to the Colorado Springs City Council where I will be seeking to overrule the city planning commissions split decision resulting in being able to keep my existing fence and wall intact. It is my right to appeal the planning commissions split decision as it was the right of my neighbors at 17 Marland to appeal city planning departments decision to grant me the non-use variance. With that in mind I would expect the HOA

board would respect the city councils decision if this body does choose to vote in my favor in keeping my retaining wall and fence at the current height.

It's important to point out that my retaining wall and fence height, which is in violation of the city code, is not the only retaining wall and fence in the HOA that violates the same city code I'm violating. The code that details the violation was updated in 2016 by the city but the pre-2016 retaining wall and fence code stills put those other structures in our HOA in violation of the retaining wall and fence set back code. I have no issue with any other home owner in this neighborhood who is also in violation of the same code and I only point this out to make it known that my retaining wall and fence is not the outlier in this neighborhood.

I appreciate the statement regarding the drainage. I will be adding more trees, bushes, mulch and grass to the carriage house and driveway area. This should provide additional water run-off mitigation.

I expect my hearing with City Council will take place by mid-March. When this decision is rendered I will contact the HOA with their findings and take any appropriate and/or necessary actions in satisfying this ruling.
