- Installation of partition glass and safety procedures in City Council Chambers
- Implementation of virtual/hybrid meetings through Microsoft Teams
- Coordinated access for citizens to engage in virtual platforms for: City Council Meetings; Colorado Springs Utilities Meetings; and Boards, Commissions and Committees

# Law Enforcement Transparency & Accountability Commission (LETAC)

City Council established LETAC in June 2020 after listening to community concerns during the Black Lives Matter movement

- Received over 800 applications for appointment
- Interviewed and selected members and two alternates

- Commission serves as a conduit for the needs of both citizens and Police Department
- Provide feedback back to City Council with policy recommendations



## Highlights

### Land Use Advancements

#### Accessory Dwelling Units (ADUs)

City Council approved ADU legislation on June 23, 2020 after extensive Staff, City Council, and public review. City Council held two Town Halls, and the item appeared on five Work Sessions.

#### Public Arts Master Plan

Unanimously approved by City Council on November 24, 2020 this is the first Public Art Master Plan creating a sustained, permanent public art program in Colorado Springs

#### Panorama Park Renovation

On August 25, 2020 City Council adopted an ordinance to appropriate \$3,700,000 to the renovation of Panorama Park


