Entegris Overview





Entegris delivers advanced materials for semiconductor and life sciences industries across the globe. Through a robust portfolio and global footprint, the company has three major divisions: Advanced Material Handling, Specialty Chemicals & Engineered Materials, and Micro-Contamination Control.

The Entegris Colorado Springs location is considered an essential business producing products that directly impact the supply chain of COVID-19 vaccine production.






- Expanding operations at existing location to produce products critical for vaccine production.
 - 4405 Arrowswest Drive
- Currently has 285 employees locally and 5,300 employees company wide







Entegris Overview



- Investment plans for expansion and job creation
 - \$24.2 million capital investment
 - \$3.2 million in purchases of construction materials
 - \$21 million in equipment and machinery
 - 38 jobs over 4 years; 43 over 5 years
 - Average wage: \$58,092

Proposed EDA



- Provide certain performance-based incentives in an effort to enable greater company investment and job growth
- Incentives provided through an Economic Development Agreement

Proposed EDA



- Recommended Economic Development Agreement:
 - Sales & Use Tax Rebate on Annual Purchases of Business Personal Property (50% of the City's 2% General Fund Rate, or 1% Total Rebate)
 - Sales and Use Tax Rebate on Purchases of Construction Materials (50% of the City's 2% General Fund Rate, or 1% Total Rebate)
 - Four Year Agreement 38 new jobs over lifetime of agreement

Financial Safeguards



- Incentive structure incurs no financial risk to the City
 - Strictly performance-based
 - Rebates are made to the company only after revenue has been collected
