**8.A.** 16-535 A Resolution Supporting the City of Colorado Springs Sponsorship of a Ring the Peak Planning Grant Application to Great Outdoors Colorado

8.**D**. <u>CPC CA</u> 16-00086

An ordinance amending Section 1503 (Home Occupation Permit Standards and Criteria) of Part 15 (Home Occupations) of Article 5 (Administration and Procedures) of Chapter 7 (Planning, Development and Building) of the Code of the City of Colorado Springs 2001, as amended, relating to the production and sales of plants, fruits, vegetables and cottage foods.

Presenter:

Peter Wysocki, Director of Planning & Community Development Peter Wysocki, Director of Planning and Community Development, presented a summary of the proposed ordinance which is supported by the Planning Commission.

Councilmember King asked if neighbors could collaborate to sell goods in one location. Mr. Wysocki stated each individual is allowed to sell their own product to consumers on their own property, collaboration is prohibited. David Andrews, Legislative Counsel, explained individuals are currently allowed to sell produce and conduct garage sales on their property. The intent of this proposal is to allow citizens to prepare and sale cottage foods, encouraging home occupation business ventures on their property.

Councilmember Knight expressed concern about traffic issues resulting from this proposal. Council President Pro Tem Gaebler stated Denver passed a similar ordinance in 2014 and what they are seeing is mostly neighbor to neighbor sales. Data does not indicate traffic has been a problem.

Council President Pro Tem Gaebler stated Food Policy Advisory Board members staff requested her assistance shepherding this ordinance through the governmental process. Lynn Harwell, Food Policy Advisory Board Member, spoke about the need to provide fresh foods to the community, the importance of this proposal and the success of a similar program in Denver. Robin Roberts, Board Chair of the Advisory Board for the Pikes Peak Small Business Development Center, spoke about the importance of providing this service to consumers and entrepreneurs

seeking the type of small business opportunities presented by this proposal. Tom Gonzalez, Deputy Director, El Paso County Public Health Department, outlined some of the health and safety requirements included in the proposal.

Councilmember Knight asked if permits will be required for those participating in this opportunity. Mr. Wysocki stated this will require a home occupation permit. Councilmember Knight stated he still has concerns about this proposal causing potential traffic issues and suggested limiting the number of days per week or operating hours to address this concern.

#### 8.E. <u>16-515</u>

A resolution adopting City Council's annual Report to the Citizens for 2015-2016, pursuant to City Charter Section 3-10(d).

Eileen Gonzalez, City Council Administrator, stated the reports are included in the Council packets. Council President Pro Tem Gaebler praised the work of Travis Duncan in preparing this report.

Councilmember Murray requested the language, "Councilmembers are responsible stewards of the resources they have been entrusted with" be changed. Ms. Gonzalez will work with Councilmember Murray to address his concerns.

#### 10. Councilmember Reports and Open Discussion

Council President Bennett stated the Annual Firefighters Memorial Service will be held Saturday morning at 10:30 in Memorial Park. Memorial Health System will have a ground breaking ceremony for their new building Friday September 16th at 10:30 am and Children's Hospital will have a ground breaking ceremony for their new building November 15, 2016. Ms. Gonzalez is in the process of scheduling a joint meeting with the Denver City Council in Colorado Springs.

Council President Pro Tem Gaebler stated she is trying a concept she is calling "Office Hours", providing consistent times at various locations within her Council district for citizens to meet with her to discuss their

ideas and concerns.

Councilmember Bagley stated September 18th is the Air Force's 69th Birthday.
