Councilmember Pico stated he will support this but, he is in opposition to the City competing with private industry to provide telecommunication service to citizens.

#### 13. Added Item Agenda

#### 13.A. 17-791

A motion directing the City Attorney to draft for City Council consideration at its regular meeting on January 24, 2017, a Resolution submitting to the registered, qualified electors of the City of Colorado Springs, Colorado, at the general municipal election to be held on April 4, 2017, a question for increasing sales and use taxes by 0.1% for a temporary period to be determined by City Council for the purpose of protecting natural areas, conserving water and maintaining parks and open spaces as a voter approved revenue change, with such provisions as will comply with applicable City Charter requirements and law.

Susan Davies with the Trails and Open Space Coalition provided a summary of this proposal. Nissa Steinhauer, local consultant with the Trust for Public Land (TPL) spoke about the process leading to this proposal. She also spoke about raising funds to support local parks and stated their survey data show citizens prefer a sales tax increase.

Councilmember King expressed concern about funds generated through this initiative replacing fund designated for parks through the general fund and encouraged the City to increase park funding through the City budget. Ms. Steinhauer stated language to this effect could be included in the proposal.

Councilmember Strand asked why this issue should be included on the ballot. Ms. Steinhauer discussed voter tendencies and preferences and stated this initiative is specific to broad maintenance of parks allowing the department to grow and adapt and leverage the funds, sort of a complement to the TOPS money.

Councilmember Murray asked how Ms. Steinhauer would address members of the business community who believe this measure may have an undesirable affect on their bottom line. Ms. Steinhauer stated parks are critical to communities and need to be taken care of to maintain the quality of life and attractiveness of the community to visitors and citizens.

Scott Anderson, Dave Munger, Bob Falcone, John Maynard and Jaymen Johnson spoke in support of this proposal

Citizens Gerald Miller and Dirk Draper spoke in opposition of this proposal.

Councilmember King asked if the City has ever instituted maintenance of effort that did not require a charter amendment or voter approval and included requirements for the use of funds by subsequent Councils. Ms. Massey stated there are two City maintenance of effort provisions she is familiar with, one regarding PPRTA and the other with PSST. The PPRTA maintenance of effort is aspirational and not binding. She is unsure about the PSST language. If this measure passes, the City Attorney's Office will draft a resolution referring a ballot question regarding this topic along with a resolution that will include a time period and maintenance of effort for the tax increase. The ballot question would be limited to 30 words. Councilmember King suggested the only way to protect and grow the park funds in the general fund along with this initiative is through maintenance of effort and asked about requiring maintenance of effort in the City Charter. Ms. Massey stated she cannot respond to that inquiry at this time because it has to do with changing the City Charter or including maintenance of effort in each referred tax collection and she would need to review options regarding each situation.

Councilmember Knight commented on the amount of the budget going to parks and stated he believes the City needs to find other ways to support parks without tax increases.

Councilmembers continued to discuss this issue and consider alternate funding sources to support City parks.

Jeff Greene, Chief of Staff, thanked the parks advocates who presented in the meeting and stated the individuals presenting this initiative were encouraged to seek information regarding this proposal. The Mayor made a commitment to the citizens of Colorado Springs to address the infrastructure issues in the City. The number one issue was transportation, these issues are being addressed. The Mayor also committed to develop an agreement with Pueblo County to resolve storm water issues and preserve the Southern Delivery System. The Mayor has spent a great deal of time thinking through this process and

has had many discussions regarding this matter. At this time the Mayor's Office does not support the advancement of this question going forward, the Mayor is focused on infrastructure needs as a first priority. The Mayor understands and supports our park system but does not support this initiative at this time.

Motion by Councilmember Strand, seconded by President Pro Tem Gaebler, that the Resolution directing the City Attorney to draft for City Council consideration at its regular meeting on January 24, 2017, a Resolution submitting to the registered, qualified electors of the City of Colorado Springs, Colorado, at the general municipal election to be held on April 4, 2017, a question for increasing sales and use taxes by 0.1% for a temporary period to be determined by City Council for the purpose of protecting natural areas, conserving water and maintaining parks and open spaces as a voter approved revenue change, with such provisions as will comply with applicable City Charter requirements and law be adopted. The motion failed by a vote of 3-6-0
