Michael Sullivan reported that BKD LLP completed their analysis of the impact of removing vacation from hours worked when calculating overtime for firefighters, and of changing the FLSA period from 27 to 18 days. They also looked at changing the FLSA period from 18 to 9 days. Upon analysis, the shorter FLSA period does not benefit employees; the recommendation from staff, then, is to continue with the 18 day FLSA period which went into effect on 1/1/17.

Mike Brink presented the independent review conducted by BKD, and explained that 5 years worth of data from the City was analyzed and used to

model the impacts. The data was also compared to other cities. The likely impact of removing vacation from hours worked when calculating overtime is a reduction of wages in aggregate of about \$237,000 over the last 5 years. The likely impact of switching FLSA cycles to 18 days is a slight reduction in the amount of overtime paid out to employees.

Council President Bennett asked how they had arrived at a 27 day cycle in the first place. Mr. Sullivan explained that it's the most common FLSA cycle for firefighters, and has been the cycle used for at least 20 years.

Councilmember Murray asked if there has been a response from the Fire Department to this report. Mr. Sullivan said the Local 5 leadership will get the report in even more detail to review.

Councilmember Strand invited Colorado Springs Professional Firefighters Local 5 to comment on the report. Dave Noblitt, President of Local 5 said he was looking forward to hearing more about the analysis and that they would like to study it before making a determination to support it. This year's vacation hours were planned without reflecting on the change from 27 to 18 days, so there is some concern and reluctance about the changes and their effect on wages. Mr. Noblitt confirmed that Local 5 asked Council to look into these changes as it was thought they might benefit the employees.

Council President Bennett asked that the matter not come before Council until the Firefighters have had a chance to be a part of the dialogue. Mr. Sullivan gave his commitment to this request.

Deputy Chief Randolph Royal updated Council that he had briefly met with BKD and has been in conversation with Local 5, and all have agreed that more study is needed.

Gallagher Amendment and Property Assessments Briefing

Kara Skinner presented an overview of the Gallagher Amendment to the Colorado Constitution, and its impact on property value assessments. She also showed a video by the Colorado Fiscal Institute on the subject. For the 2017 period, the residential assessment rate is projected to decline again, therefore property tax revenue will decline. We are unable to increase the residential assessment rate due to TABOR, as it will require a vote of the electors.

Steve Schleiker, El Paso County Assessor, reviewed the assessment process.

Councilmember Pico asked what the impact overall to total property tax revenues would be. Mr. Schleiker said that in Colorado Springs, because we

have had an increase in non-residential assessments, they will be going up, but other counties could be hurt.

Councilmember Strand asked what the success rate is for people who appeal an assessment for a reduction in tax. Mr. Schleiker estimated that about 50% are approved.

Proposed Rail-Served Industrial Park, Southern El Paso County - Project Preview

Council President Bennett explained that he asked for this project preview of a proposed rail-served industrial park that would be outside of the City of Colorado Springs, but be an important addition to the region's economy. The Council's role in reviewing this project is related to utilities.

Hannah Parsons, Chief Economic Development Officer of the Colorado Springs Chamber of Commerce & EDC, told Council they see it as a high priority because of much business interest; already they have had to turn away 37 proposed projects because we have no rail-served industrial yard. These are many potential jobs.

Consultant Gary Barber said the next step is to move forward into feasibility studies, and working with teams.

Council President Bennett asked if rate payers would be responsible for maintaining the rail service tracks not relevant to the Ray Nixon Power Plant. Mr. Barber said they would not.

Councilmember Murray asked if the County had accepted this project. Mr. Barber said the county has not entered into a Memorandum of Understanding, as they don't want to give the appearance of approval for zoning at this stage. But the community and the property owner have shown cooperation and commitment.

President Pro Tem Gaebler asked for clarification of the Council's role in this project. Mr. Barber said the City is the regional economic engine for bringing jobs to the project, but their role is only as a Utility Board.

Councilmember Pico noted that Utility Board representatives have already been engaged.

Councilmember Strand asked Bill Cherrier, Chief Planning and Finance Officer for Colorado Springs Utilities, to comment on this project. Mr. Cherrier has reviewed the project and believes there are modifications that can be made; details have not yet been worked through.

President Bennett asked that Council be engaged in the process, as it wants to be proactive.
