**Summary:**  
This Ordinance enumerates the fees applicable to bicycle-share business licenses.

**Previous Council Action:**

**Background:**  
If City Council adopts a new section of the business licensing code applicable to bicycle-share businesses, the fees associated with those newly adopted licenses will also need to be implemented. Because the fees are enumerated in part 5 of the existing business licensing code, a separate ordinance to amend the fees section to identify the fees for these newly adopted business licenses is necessary. Standard general business license fees for the application fee (\$0.00), annual license fee

(\$90.00), and the duplicate license fee (\$5.00) will apply for the bicycle-share business license.
