Summary:

Colorado Springs Utilities (Utilities) requests City Council to set the Street Lighting Revenue Requirement for the provision of street lighting services from January 1, 2024 through December 31, 2024 in the amount of \$4,753,080.

Background:

The street lighting infrastructure operated by Utilities within the City of Colorado Springs (City) is part of the system of utilities owned and operated for the convenience and necessity of the citizens of the City. Colorado Springs City Code § 12.9.103 authorizes Utilities to assess and collect a street lighting service charge from the City for the provision of street lighting services. Additionally, City Code § 12.9.105 requires Utilities to annually prepare a revenue requirement setting forth the amount that must be recovered for street lighting service pursuant to City Code § 12.9.103.
