**Background:**

The City's Infill Comprehensive Plan Supplement (Chapter) recommends the continued use, maintenance and implementation of the attached Infill Action Plan, as recommended by the Infill

Steering Committee. This resolution would endorse this document for ongoing use. A few of the recommended action items are completed, with several more underway. Others are expected to be initiated in the near future, with the remainder to be considered in light of City resources and priorities. Many of these recommendations are addressed in or are aligned with existing City strategic plans.
