Review And Approval of Decision and Order and Resolution Regarding Changes to the Utilities Rules and Regulations

Summary:
The City Attorney's Office-Utilities Division will present a draft decision and order and draft resolution for the 2017 Utilities Rules and Regulations rate case based upon the October 25, 2016 public hearing held on Colorado Springs Utilities' September 13, 2016 rate case filing. City Council will review the documents and may direct any changes to be made to the documents prior to their final submission for approval at the November 8, 2016 Regular Meeting.

Previous Council Action:
City Council held a public hearing on October 25, 2016 regarding Colorado Springs Utilities' September 13, 2016 rate case filing.

Background:
On September 13, 2016 Colorado Springs Utilities submitted a 2017 rate case filing that included proposed changes to the Utilities Rules and Regulations to be effective January 1, 2017. In accordance with Colorado Springs City Code § 12.1.107, City Council held a public hearing on October 25, 2016 regarding Colorado Springs Utilities' 2017 Utilities Rules and Regulations rate case.

The draft decision and order summarizes Colorado Springs Utilities' 2017 rate filing and the record of the public hearing held on October 25, 2016. The draft decision and order also contains City Council's initial directions at that public hearing regarding the 2017 Utilities Rules and Regulations rate case. The draft resolution for the Utilities Rules and Regulations rate case is also presented for review and comment by City Council. Any revisions to the draft decision and order or to the draft resolution directed by City Council will be incorporated into the final decision and order and final resolution presented for approval by City Council on November 8, 2016.

Financial Implications:

The decision and order and the resolution regarding proposed changes to Utilities Rules and Regulations authorize changes to Electric Line Extensions and Services, Extension of Natural Gas Mains and Services, Water and Wastewater Development Charges.
