**Summary:**

Location: 1301, 1353, and 1355 S. 8th Street

This project is a concept plan for a 7.2-acre site. The concept plan utilizes a portion of the property for an indoor recreation facility.

**Previous Council Action:**

None

**Background:**

The application under review is for a zone change from OC and R-5 to PBC. The site is located adjacent to 8th street. The OC portion of the site was originally developed as an office complex and the R-5 portion of the site was original developed as a church. The office portion of the site has remained office, but the church has recently turned into a climbing gym, which is under the indoor sports and recreation use category. Indoor sports and recreation is not a permitted use in the R-5 zone district. Indoor sports and recreation and offices are permitted uses in the PBC zone district;

therefore, the applicant is requesting a zone change to PBC for the entire site. The PBC zoning is consistent with the zoning along 8th street. The corridor contains OC, PBC, C-5 and C-5 zoning.

**Board/Commission Recommendation:**

At their meeting on August 20, 2015 the Planning Commission voted 9-0 to approve the Concept Plan.

**Stakeholder Process:**
